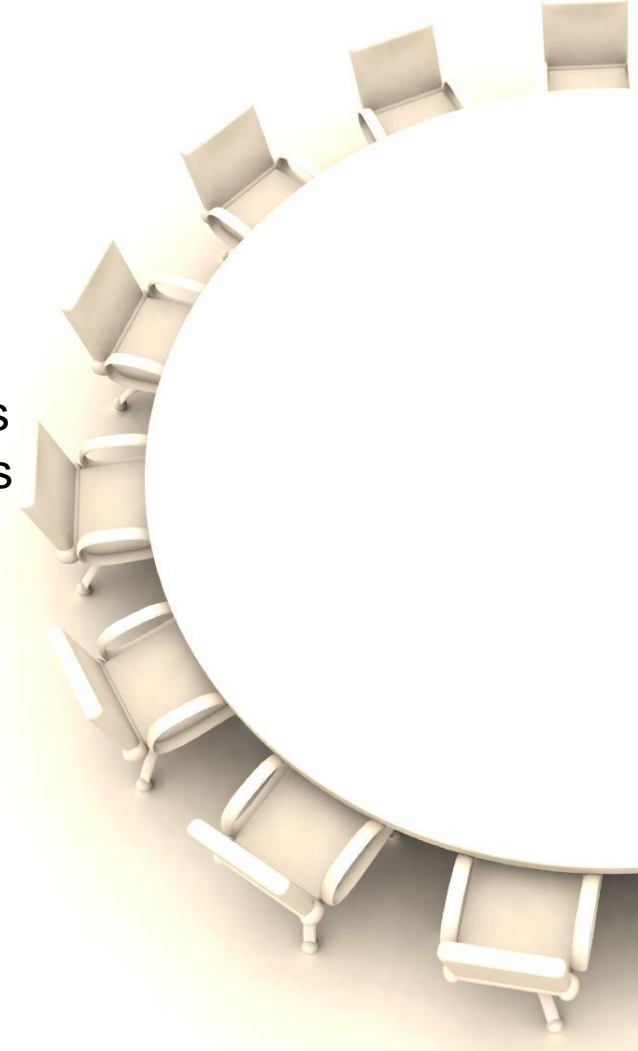

# Common Scorecard: testing a draft

## Testing and feedback (rest of 2015)

- Develop initial draft and launch “test”
- Seek feedback on 1) each measure, 2) ease of access and administrative burden of reporting, and 3) patient attribution

## Refine and launch v2.0 (2016)

- Refine draft based on feedback from providers and payers
- Launch v2.0 of scorecard linked to new payment models

## Continuous improvement (2016+)

- Refine measures over time
- Further integrate with clinical data

# Initial feedback on the draft scorecard

## Some positive first steps...

- It would be great to really align payers around one set of measures
- Making progress on these measures as a state would be a positive step forward
- Widespread achievement of the transformation milestones would be a great success for primary care in Delaware

## ...but opportunities to improve

- Initial draft does not yet strike the right balance between traditional quality measures and measures of population health management
- Claims are not the best source for clinical measures
- Reporting for some measures may be burdensome for providers to implement

- **“Test” period this summer is to collect further feedback**
- **Will make technical refinements later in 2015 and introduce v2.0 in early 2016 that will be linked to new payment models**

# Update on Healthy Neighborhoods

## Population Health Scorecard (PHS)

- America's Health Rankings will be the basis for Delaware's PHS
  - Mental Health Professional Shortage Areas (HPSAs) will be added to the scorecard
- Other metrics will be gathered and tracked alongside the scorecard to fill gaps and provide additional detail

## Healthy Neighborhood Priorities

- Healthy Neighborhoods will be able to select their own priority focus from four themes
  - Healthy Lifestyle
  - Maternal and Child Health
  - Mental Health & Addiction
  - Disease Management

## Other Updates

- Healthy Neighborhoods is being actively contacted by existing collaborative bodies and initiatives looking to learn more and assess potential to partner
