**What do I need to bring with me?** For other locations, please call DACA @ 302-656-8200

- Picture ID & Soc. Security cards for you and your spouse. Dependents Soc. Security cards.
- If social SS card is unavailable, order a new one from the Social Security Administration.
- Bring the SS application letter with the Soc Sec # from Soc Security Administration.
- If applicable, bring ITIN assignment letter for you, your spouse and dependents.
- Proof of foreign status, if applying for ITIN.
- Dates of birth for yourself and all family members you are claiming.
- A copy of 2012 federal and state tax returns, If available.
- W-2s and 1099-R, if any, for all jobs you held in 2013.
- Form 1099-G if you received unemployment insurance in 2013.
- Form 1099-INT, if you received interest and/or dividends in 2013.
- If claiming Childcare expenses, bring documentation of expenses and childcare agency's ID or Social Security number and address.
- If filing your taxes with a spouse, please bring your spouse for their signature.
- A deposit slip or voided check for direct deposit of your refund.

  - Identificación con foto y tarjetas de seguro social para Ud. y su familia
  - Si no tiene tarjeta de seguro social, traiga la carta con el ITIN para Ud. y sus dependientes.
  - Si no tiene tarjeta de seguro social ni ITIN (numero para llenar impuestos) podemos ayudarle a btener su ITIN gratis.
  - Prueba de status extranjero, si está aplicando para un ITIN
  - Fechas de nacimiento suyo y de sus dependientes, incluyendo esposo o esposa
  - Una copia de sus impuestos federales y estatales del año anterior, si están disponible
  - W-2s y 1099-R, si disponibles, para todos los trabajos que tuvo en 2013
  - La forma 1099-G si recibió seguro de desempleo en el 2013
  - La forma 1099-INT, si recibió interés y/o dividendos en el 2013
  - Si está reclamando gastos por cuidado de niños, documentación of gastos y número de Identificación de la agencia o seguro social del proveedor
  - Si está llenando sus impuestos con el esposo (a), ambos deben estar presente
  - Un cheque cancelado o formulario de depósito para el depósito directo de su reembolso.
