## DELAWARE INSTITUTE FOR MEDICAL EDUCATION AND RESEARCH

## (DIMEK)

Through the Delaware Institute for Medical Education and Research (DIMER), Delaware has an agreement with two medical schools in Philadelphia – Sidney Kimmel Medical College (Sidney Kimmel) and the Philadelphia College of Osteopathic Medicine (PCOM). Each year Sidney Kimmel agrees to accept at least five. In return, Sidney Kimmel receives \$1 million and PCOM receives \$12,500 per student, up to \$250,000, regardless of how many Delaware applicants into the freshman class and PCOM receives \$12,500 per student, up to \$250,000, regardless of how many Delawareans matriculate there. Also through DIMER, Delaware has provided tuition assistance to DIMER students at both Sidney Kimmel and PCOM, provided funding to residency and medical education programs at the University of Delaware (UD) and Christiana Care Health System (Christiana), and matched federal funding for the State Loan Repayment Program (SLRP).

DIMER Appropriations History
