QHP Standards Updates

Proposed QHP Standards for Plan Year 2018

- The QHP Standards were updated to reflect passage of SB 238, which adds QHPs as Mandatory Reporting Entities for the Delaware Health Care Claims Database (HCCD). Under SB 238, QHPs are required to submit claims data to the Delaware Health Information Network for inclusion in the HCCD.
- Commissioners have the final draft to review for a vote today



Crosswalking Plans

- If an Issuer discontinues a certain plan, the subscriber of that plan will be notified in writing by November 1, 2016, that:
 - If NO action is taken by the subscriber, they will automatically be enrolled in a different, but very similar, plan.
 - The subscriber may also shop around for another plan with that same Issuer or they may choose a different Issuer altogether and enroll in an entirely different plan.

Date	Milestone
November 1, 2016	Open enrollment began for Plan Year 2017
December 15, 2016	Deadline to enroll or re-enroll for coverage to be effective on January 1, 2017
January 31, 2017	End of open enrollment for Plan Year 2017
