









## Christiana Care Women's and Children's Services Transformation Project

Christiana Care Health Services proposes to transform the Christiana Hospital campus to enhance value for our patients, create space to innovate new care models, and allow for better integration between services. This project will address chronic facility issues in the Women's and Children's Services area and include an eight (8) story patient tower and a parking garage.

The proposed project will address the following major facility needs:

- Neonatal intensive care unit with 70 single family rooms and a 10-bed continuing care nursery to care for babies with neonatal abstinence syndrome
- Expanded obstetrics capacity to manage current and future volume with expanded triage area, 4-8 additional labor and delivery suites, and 72 new private, family-centered mother-baby rooms
- Conversion of the existing mother-baby units to allow the campus to have all private medical-surgical beds

The project includes both new construction and renovation of existing facilities and equipment purchase with an estimated capital expenditure of \$258,000,000.
