The Clinical Challenge: Essential Tremor & Parkinson's Disease

 A neurological condition that includes involuntary shaking or trembling movements in one or more parts of the body.

 Can make it hard to do daily life tasks and can lead to disability.

 Multiple causes, including Parkinson's Disease and genetics. Most commonly affects older adults.

- Affects approximately 1% of the population overall and 5% of adults age 60+.
- Will increasingly impact Delawareans as population ages.





Current Treatment Options for Essential Tremor & Parkinson's Disease

Provider-prescribed medication is currently the only option available in Delaware, and this often has limited efficacy.

ChristianaCare would like to offer a new treatment option for Delaware.



NEW TREATMENT OPTION

MR-Guided Focused Ultrasound

ChristianaCare seeks to purchase an MR-Guided Focused Ultrasound to provide a new treatment option in Delaware for patients with essential tremor and tremors from Parkinson's disease.

- Anticipating 400 patients served over the next three years.
- Utilizing ChristianaCare Neurologists and contracting Delaware Neurosurgery Group to provide patient treatment.

This treatment will be the only MR-guided Focused Ultrasound option for patients in the State of Delaware.









Effect on Health Care Costs and Charges

- The MR-Guided Focused Ultrasound will not materially impact the overall costs and charges of health care to the community.
- This technology will enable physicians in Delaware and throughout the region to refer patients locally to ChristianaCare for the procedure.
- Making this treatment locally available supports improving population health for the community we serve in Delaware, especially elderly and low-income individuals who often face challenges accessing care.

Expected Costs

- Capital investment of \$2.23M; to be funded through cash reserves
 - MR-guided Focused Ultrasound equipment.
 - Minor renovations.
- Year 1 projected revenue is \$1,148,187, and projected operating expense is \$772,732.
- Health care cost savings due to reduction in provider-prescribed medication and incidence of surgical intervention have not been quantified.

MR-guided Focused Ultrasound will be located on the ChristianaCare Newark Campus in its existing MRI suite.




Figure 1-1: Schematic Representing Layout of Type 1.0 System Components In-Site



- 2. Relevant certifications and accreditation status are in good standing.
- 3. Letters in support of the proposal, as well as administrative, clinical and leadership positions have been provided.
- Signed participation agreement with DHIN, and is submitting records / accessing data from DHIN for care coordination purposes.
- Appropriate balance in consideration of access, cost, and quality of care issues are seriously embraced in the application.
- the proposal supports access and continuity of care, chronic disease management, use of health information technology and affiliation with the Delaware Health Information Network (DHIN), care coordination and other strategies to facilitate Delaware's transition to valuebased payment models to improve overall health outcomes.
- The proposal, where possible, contributes to the care of the medically indigent.

(2) The need of the population for the proposed project;

- 1. The proposal demonstrates a clear public need for the service(s) proposed, as well as identifying the population to be served, as well as data-oriented evidence.
- 2. The proposal specifies its plan for care of patients without private insurance coverage, as well as its plan for care of medically underserved populations with the proposed service area.

(3) The availability of less costly and/or more effective alternatives to the proposal, including alternatives involving the use of resources located outside the State;

- 1. The proposal provides information about alternative providers of the proposed service, referencing the specific providers that now offer the proposed service and the impact of those parties, including financial information indicating whether these alternative providers are more or less costly in the provision of the service.
- The applicant has taken into account the availability of out-of-state, yet geographically close, health care service resources.

(4) The relationship of the proposal to the existing health-care delivery system;

- 1. The applicant has described in detail how and where the proposed patient population is currently being served. The applicant has described existing referral patterns in the proposed service area and demonstrated that the proposed project shall not result in an unnecessary duplication of existing or approved health care facilities or services.
- 2. To ensure appropriate continuity of care, accessibility, and related quality-enhancing considerations, the applicant has provided information regarding the applicant's established referral arrangements with other providers in the service area. (6) The anticipated effect of the proposal on the costs of and charges for health care; and

- 1. The applicant has demonstrated how the proposal will impact the financial strength of the health care system in the state. Specifically, the applicant has demonstrated how the proposed project will improve cost-effectiveness of health care services within the service area.
- 2. The applicant has also demonstrated how the proposal will impact cost and charges to the individual(s) for health services (where applicable).

(7) The anticipated effect of the proposal on the quality of health care.

- 1. The applicant has demonstrated how the proposed project will improve quality and accessibility of health care services within the service area, including but not limited to, the provision of or any change in the access to services for Medicaid recipients and indigent persons as well as the impact of providing services to these populations.
