

Delaware Weekly Influenza Report MMWR Week 46 (November 10, 2019- November 16, 2019) Delaware Division of Public Health

National Influenza Synopsis 2019-2020:

National data are updated Friday of each week. Please visit http://www.cdc.gov/flu/weekly/ for the most current information. Geographic spread of influenza during MMWR Week 46 (November 10- November 16, 2019) was reported as follows:

- No Activity was reported in one state (Rhode Island)
- Sporadic Influenza Activity was reported in District of Columbia, the U.S. Virgin Islands and 11 states (Alaska, Idaho, Kansas, Maine, Missouri, Montana, Ohio, Pennsylvania, South Dakota, Utah and Vermont)
- Local Influenza Activity in Puerto Rico and 23 states (Arkansas, Colorado, Delaware, Illinois, Indiana, Iowa, Kentucky, Maryland, Michigan, Minnesota, Mississippi, Nebraska, New Hampshire, New Jersey, New York, North Carolina, North Dakota, Oklahoma, Virginia, Washington, West Virginia, Wisconsin and Wyoming)
- Regional Influenza Activity was reported in nine states (Arizona, Connecticut, Florida, Georgia, Hawaii, New Mexico, Oregon, Tennessee and Texas).
- Widespread Influenza Activity was reported in six states (Alabama, California, Louisiana, Massachusetts, Nevada and South Carolina)).
- Guam did not report.

Summary of International Influenza Activity:

- In the temperate zone of the northern hemisphere, influenza activity remained at inter-seasonal levels in most countries. However, influenza activity continued to increase across the countries of the Arabian Peninsula.
- In the Caribbean, and tropical South American countries, influenza activity was low overall, except for Cuba and Jamaica. In Central American countries, influenza activity was elevated in El Salvador and Nicaragua.
- In tropical Africa, influenza activity remained elevated in some countries of Western Africa.
- In Southern Asia, influenza activity was low across reporting countries, but started to increase in Iran (Islamic Republic of).
- In South East Asia, influenza activity continued to be reported in Lao PDR.
- In the temperate zones of the southern hemisphere, influenza activity was low in most countries, though influenza B virus detections continued to be reported in Chile.
- Worldwide, seasonal influenza A viruses accounted for the majority of detections.

Delaware Influenza Surveillance 2019-2020:

During MMWR Week 46, there were 20 laboratory-confirmed cases of influenza reported among Delaware Residents. Reports of influenza-like-illness (ILI) received from participating providers, facilities, and institutions in Delaware show ILI is 0.08% compared to Delaware's 2019-2020 baseline of 1.9%. Nationally, 2.5% of visits to a healthcare provider were for ILI, which an increase from last week and is now above the 2019-2020 national baseline of 2.4%. Four of 10 regions were at or above their baselines

Level of Influenza Activity in Delaware, MMWR Week 46:

Local

Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in a single region of the state.

Influenza-like illness (ILI) is defined as patients presenting with fever of 100° F or greater, cough and/or sore throat in the absence of a known cause other than influenza.

CDC Definitions:

No Activity: No laboratory-confirmed cases of influenza and no reported increase in the number of cases of ILI.

Sporadic: Small numbers of laboratory-confirmed influenza cases or a single laboratory-confirmed influenza outbreak has been reported, but there is no increase in cases of ILI.

Local: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in a single region of the state.

Regional: Outbreaks of influenza or increases in ILI and recent laboratory-confirmed influenza in at least two but less than half the regions of the state with recent laboratory evidence of influenza in those regions.³

Widespread: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in at least half the regions of the state with recent laboratory evidence of influenza in the state.

¹2018-2019 Region 3 (DE, DC, MD, PA, VA and WV) Baseline = 1.9%.

² Laboratory-confirmed case = case confirmed by viral culture or PCR.

³ Region = population under surveillance in a defined geographical subdivision of a state. Regions typically include several counties. Regional does not apply to states with < four counties.

Confirmed Cases of Influenza by Type and Subtype/Lineage, Delaware 2019-2020 Influenza Season




Figure 1: During MMWR Week 46 for the 2019-2020 Influenza season, there were 12 confirmed cases of Influenza reported by ILINet providers. Ten were identified as subtype B/Victoria and two were identified as Flu A/H1N1. The percent positive for samples tested was 13.04%.

U.S. Outpatient Influenza-Like Illness Surveillance Network (ILINet) Sentinel Providers

An ILINet (sentinel) provider conducts surveillance for influenza-like illness (ILI) in collaboration with the Division of Public Health and the Centers for Disease Control and Prevention (CDC). Data reported by ILINet providers, in combination with other influenza surveillance data, provide a national and statewide picture of influenza activity in the U.S.




Figure 2: Delaware's regional baseline² for healthcare visits relating to ILI symptoms in the 2019-2020 Influenza Season is 1.9% and the national baseline³ is 2.4%. In MMWR Week 46, the amount of ILI related visits reported by sentinel providers decreased from 0.16% to 0.08%.

Percentage of Emergency Department (ED) Visits Due to ILI/Influenza by MMWR Week, Delaware 2019-2020




Figure 3A: Syndromic data collected from ESSENCE shows that in the weeks preceding the start of the 2019-2020 Influenza season and through MMWR Week 46, there was an increasing trend in the percentage of ED visits due to ILI/Flu symptoms.

County-Specific Percentage of ED visits Due to ILI/Influenza by MMRW Week, Delaware 2019-2020




Figure 3B: Syndromic data collected from ESSENCE shows that in the weeks preceding the start of the 2019-2020 Influenza season and through MMWR Week 46 stratified by Delaware's three counties.

NOTE: Data provided do not reflect the total number of individuals who have been infected with the influenza virus in Delaware during the reporting period due to the following factors:

- Many people ill with influenza-like symptoms do not seek medical care.
- Many who do seek medical care are not tested for influenza.
- The Delaware Public Health Laboratory is limited by capacity to processing a maximum of three specimens per day from each reporting entity.
