

Delaware Weekly Influenza Report MMWR Week 40 (September 26, 2020- October, 3, 2020) Delaware Division of Public Health

National Influenza Synopsis 2020-2021:

National data are updated Friday of each week. Please visit <u>https://www.cdc.gov/flu/weekly/</u> for the most current information. The percentage of respiratory specimens testing positive this week is 0.21% this week. No influenza-associated pediatric deaths have been reported to the CDC. For this flu season, geographic spread of influenza will not be reported per official CDC communication.

Summary of International Influenza Activity:

- The current influenza surveillance data should be interpreted with caution as the ongoing COVID-19 pandemic have influenced to varying extents health seeking behaviors, staffing/routines in sentinel sites, as well as testing priorities and capacities in Member States. The various hygiene and physical distancing measures implemented by Member States to reduce SARS-CoV-2 virus transmission have likely played a role in reducing influenza virus transmission.
- Globally, influenza activity was reported at lower levels than expected for this time of the year. In the temperate zones of the southern hemisphere, the influenza season has not started. Despite continued or even increased testing for influenza in some countries in the southern hemisphere, very few influenza detections were reported.
- In the temperate zone of the northern hemisphere, influenza activity remained below interseasonal levels.
- In the Caribbean and Central American countries, there were sporadic, or no influenza detections reported. Severe acute respiratory infection (SARI) activity, likely due to COVID-19, remained elevated in some reporting countries.
- In tropical South America, tropical Africa and Southern Asia there were sporadic or no influenza detections across reporting countries.
- In South East Asia, sporadic influenza detections were reported in Lao People's Democratic Republic and Thailand.
- Worldwide, of the very low numbers of detections reported, seasonal influenza B viruses accounted for the majority of detections.

Delaware Influenza Surveillance 2020-2021:

During MMWR Week 40, there were no (n=0) laboratory-confirmed cases of influenza reported among Delaware Residents. Reports of influenza-like-illness (ILI) received from participating providers, facilities, and institutions in Delaware show ILI is .41% compared to Delaware's 2020-2021 baseline of 1.9%. Nationally, 1.1% of visits to a healthcare provider were for ILI, which is below the 2020-2021 national baseline of 2.6%. All regions were below baselines.




Figure 1: Confirmed Cases of Influenza by Type and Subtype/Lineage, Delaware 2020-2021 Influenza Season





U.S. Outpatient Influenza-Like Illness Surveillance Network (ILINet) Sentinel Providers

An ILINet (sentinel) provider conducts surveillance for influenza-like illness (ILI) in collaboration with the Division of Public Health and the Centers for Disease Control and Prevention (CDC). Data reported by ILINet providers, in combination with other influenza surveillance data, provide a national and statewide picture of influenza activity in the U.S.





Delaware's regional baseline² for healthcare visits relating to ILI symptoms in the 2020-2021 Influenza Season is 1.9% and the national baseline³ is 2.6%. In MMWR Week 40, the amount of ILI related visits reported by sentinel provider was 0.41%.

²The regional baseline is calculated by the CDC using non-influenza weeks from the previous three influenza seasons. Delaware is in Region 3, which also includes DC, MD, PA, VA, and WV.

³The National baseline is calculated by the CDC using non-influenza weeks from the previous three influenza seasons.




Figure 3: Percentage of Emergency Care Visits Due to ILI/Influenza by MMWR Week, Delaware 2020-2021

Syndromic data collected from ESSENCE shows that ILI trends have been consistently below Delaware's ILI baseline levels since Week 13, 2020. In the weeks preceding the start of the 2020-2021 Influenza season and through MMWR Week 40, the percentage of ED visits due to ILI/Flu symptoms has been low.

NOTE: Data provided do not reflect the total number of individuals who have been infected with the influenza virus in Delaware during the reporting period due to the following factors:

- Many people ill with influenza-like symptoms do not seek medical care.
- Many who do seek medical care are not tested for influenza.
- The Delaware Public Health Laboratory is limited by capacity to processing a maximum of three specimens per day from each reporting entity.
