# National Influenza Synopsis 2021-2022:

National data are updated Friday of each week. Please visit https://www.cdc.gov/flu/weekly/ for the most current information. The percentage of national respiratory specimens testing positive was at 0.7% this week. No new influenza-associated pediatric deaths were reported to the CDC this week. The total for the 2021-2022 season is zero influenza associated pediatric deaths.

## **Summary of International Influenza Activity:**

- The current influenza surveillance data should be interpreted with caution as the ongoing COVID-19 pandemic
  has influenced to varying extents health seeking behaviors, staffing/routines in sentinel sites, as well as testing
  priorities and capacities in Member States. The various hygiene and physical distancing measures implemented
  by Member States to reduce SARS-CoV-2 virus transmission have likely played a role in reducing influenza
  virus transmission.
- Globally, despite continued or even increased testing for influenza in some countries, influenza activity remained at lower levels than expected for this time of the year.
- In the temperate zones of the northern hemisphere, influenza activity remained at inter-seasonal levels. Both influenza A and B were detected, and respiratory syncytial virus (RSV) was increased and higher than in previous years in some countries.
- In the Caribbean and Central American countries, sporadic influenza A and B virus detections, as well as elevated RSV activity were reported in some countries.
- In tropical South America, no influenza detections were reported, however RSV activity remained elevated in some countries.
- In tropical Africa, a few influenza detections of predominately influenza A and some influenza B viruses were reported. Previously increased activity in West African appeared to be decreasing.
- In Southern Asia, the number of influenza virus detections reported was in a similar range to previous seasons with detections of influenza A and B viruses. Previously elevated levels of severe acute respiratory infections (SARI) in some countries appeared to decrease.
- In South-East Asia, few detections of influenza A(H3N2) and influenza B were reported from Myanmar.
- In the temperate zones of the southern hemisphere, influenza activity remained at inter-seasonal levels. Elevated RSV activity continued to be reported in some countries.
- Globally, among influenza detections, influenza B viruses predominated.
- National Influenza Centres (NICs) and other national influenza laboratories from 102 countries, areas or territories reported data to FluNet for the time period from 11 October 2021 to 24 October 2021 (data as of 2021-11-05 10:02:16 UTC). The WHO GISRS laboratories tested more than 307999 specimens during that time period. 2199 were positive for influenza viruses, of which 875 (39.8%) were typed as influenza A and 1324 (60.2%) as influenza B. Of the sub-typed influenza, A viruses, 186 (36.2%) were influenza A(H1N1) pdm09 and 328 (63.8%) were influenza A(H3N2). Of the characterized B viruses, 1 (0.1%) belonged to the B-Yamagata lineage and 1176 (99.9%) to the B-Victoria lineage.

#### Delaware Influenza Surveillance 2021-2022:

During MMWR Week 45, there was 3 laboratory-confirmed case of influenza reported among Delaware Residents. Reports of influenza-like-illness (ILI) received from participating providers, facilities, and institutions in Delaware show ILI is 0.68% compared to Delaware's 2021-2022 baseline of 2.0%. Nationally, 2.1% of visits to a healthcare provider were for ILI, which is below the 2021-2022 national baseline of 2.5%. All regions were below baselines.

## Past Delaware Influenza Surveillance from 2020-2021:

Last Season, during MMWR Week 45, there was 1 laboratory confirmed cases of influenza among Delaware Residents. The ILI rate was 0.80% compared to Delaware's 2020-2021 baseline of 1.9%. The rate nationally for the 2020-2021 season, MMWR Week 45, was 1.5% of visits to a healthcare provider were for ILI compared to the 2020-2021 national baseline of 2.6%.

# Past Delaware Influenza Surveillance from 2019-2020:

The previous season, during MMWR Week 45, there was 12 laboratory confirmed cases of influenza among Delaware Residents. The ILI rate was 0.16% compared to Delaware's 2019-2020 baseline of 1.9%. The rate nationally for the 2019-2020 season, MMWR Week 45, was 2.3% of visits to a healthcare provider were for ILI compared to the 2019-2020 national baseline of 2.4%.

# Level of Influenza Activity in Delaware, MMWR Week 45:

#### **SPORADIC**

CDC Definitions:

No Activity: No laboratory-confirmed cases<sup>2</sup> of influenza and no reported increase in the number of cases of ILI.

**Sporadic:** Small numbers of laboratory-confirmed influenza cases or a single laboratory-confirmed influenza outbreak has been reported, but there is no increase in cases of ILI.

Local: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in a single region of the state.

Regional: Outbreaks of influenza or increases in ILI and recent laboratory-confirmed influenza in at least two but less than half the regions of the state with recent laboratory evidence of influenza in those regions.<sup>3</sup>

Widespread: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in at least half the regions of the state with recent laboratory evidence of influenza in the state.

Influenza-like illness (ILI) is defined as patients presenting with fever of 100° F or greater, cough and/or sore throat.





#### U.S. Outpatient Influenza-Like Illness Surveillance Network (ILINet) Sentinel Providers

An ILINet (sentinel) provider conducts surveillance for influenza-like illness (ILI) in collaboration with the Division of Public Health and the Centers for Disease Control and Prevention (CDC). Data reported by ILINet providers, in combination with other influenza surveillance data, provide a national and statewide picture of influenza activity in the U.S.




Delaware's regional baseline<sup>2</sup> for healthcare visits relating to ILI symptoms in the 2021-2022 Influenza Season is 2.0 % and the national baseline<sup>3</sup> is 2.5%. In MMWR Week 45, the amount of ILI related visits reported by sentinel provider was 0.68%.

Syndromic data collected from ESSENCE shows that from Week 1 through Week 45, the percentage of ED visits due to ILI/Flu symptoms has been rising. The percentage of ED visits for ILI for Week 45 was highest in Sussex County (3.45%), followed by Kent County (1.82%), and New Castle County (1.01%).



Syndromic data collected from ESSENCE shows that from Week 1 through Week 45, the percentage of ED visits due to RSV symptoms has been rising. The percentage of ED visits for ILI for Week 45 was highest in New Castle County (0.75%), followed by Kent County (0.48%), and Sussex County (0.22%).

**NOTE:** Data provided do not reflect the total number of individuals who have been infected with the Influenza virus or Respiratory Syncytial virus in Delaware during the reporting period due to the following factors:

- Many people ill with influenza-like symptoms do not seek medical care.
- Many who do seek medical care are not tested for influenza.
- The Delaware Public Health Laboratory is limited by capacity to processing a maximum of three specimens per day from each reporting entity.
