Bona-Fide Physician-Patient Relationship What Are We Looking For to Meet the Intention of the Law?

• The patient must be under the care of the certifying physician for 6 months or more;

AND

• During this time the certifying physician must have cared for the patient's qualifying condition.

If the above cannot be demonstrated, then 1 of the following 3 documentation items are acceptable...



Option 1: Progress Notes From Another Physician or a Physician-Specialist are Acceptable

The progress notes must

 demonstrate a bona-fide patient relationship as described above

AND

• must validate the qualifying condition.

With respect to validating the qualifying condition...



Validation of Qualifying Condition in Progress Notes from Another Physician

- Radiological reports alone are not acceptable because many individuals have abnormalities on radiological assessments which are unrelated to qualifying conditions (e.g. chronic pain).
- Laboratory reports for HIV/AIDS are acceptable.
- Laboratory reports alone for hepatitis are not acceptable because the law specifies that cirrhosis must be decompensated to be a qualifying condition.



Validation of Qualifying Condition in Progress Notes from Another Physician

- Acupuncturists, massage therapists, physical therapists and chiropractor reports are not acceptable.
- Progress notes provided by APNs or PAs can be used to demonstrate a qualifying condition if they are acting under the direction of a physician.
- The last patient visit must be no more than 12 months from the date of the application.





Option 2: A Letter From Another Physician Affirming That the Patient Has a Qualifying Condition Which the Physician has Treated for at least Six Months

- The letter must be on the physician's letterhead.
- The last patient visit must be no more than 12 months from the date of the letter.

OR



Option 3: Progress Notes or a Letter from a Physician-Specialist Affirming That the Patient has a Qualifying Condition Within the Physician's Specialty Area

• Examples: (1) oncologist diagnosing/caring for a patient with cancer; (2) neurologist diagnosing/caring for a patient with ALS or MS.


 In this situation, the 6 month requirement for a physicianspecialist is waived.




Delaware Medical Marijuana Patient Cards Issued, FY 13 - FY 16 (partial)

Request for Proposal HSS 16-003

 - Opening date depends on facility preparation/grow process
- Proposal review team
