New Income Eligibility Guidelines

Effective January 20, 2011, the Federal Government updated Federal Poverty Level (FPL) Guidelines for 2011. The change of the FPL impacts the SFL Program income eligibility guidelines. Below please find the SFL 2011 income eligibility guidelines:

New Office Locations

SFL Screening Guidelines

As many providers know, the SFL Program's Medical Advisory Board annually reviews and approves SFL's screening and diagnostic guidelines to ensure the program is utilizing best practices and adhering to current standards of care. Below are the approved screening and diagnostic guidelines that the SFL program uses:

Breast Cancer screening—National Comprehensive Cancer Network (NCCN) Breast Cancer Screening Guidelines

Cervical Cancer Screening—American Society of Colposcopy and Cervical Pathology (ASCCP) and the American College of Obstetrics and Gynecology (ACOG)

Colorectal Cancer Screening—Guidelines developed by the SFL Medical Advisory Board (call SFL office for copy)

Prostate Cancer Screening— Guidelines developed by the SFL Medical Advisory Board (call SFL office for copy).
