Ken-Joined March for Meals with Modern Maturity Center and Meals on Wheels; with many government officials joining.

Jack-holding major program on May 5 at the National Harbor highlighting problems with opiate abuse and its effects on seniors. Would also like to partner with Katie and the Alzheimer's Association

CF-Secretary Walker coming to the Modern Maturity Center on April 20 for the Community on Aging, which is an open public meeting. Will be sending out more information it. Thank you to Jim Young for his service to the committee.

AG-is speaking up and down the state on numerous topics but knows this is a very important topic for the Secretary.
