# I. Call to Order

The meeting was called to order at 10:03 am by Robert Overmiller.

# II. Review of Minutes September 3, 2019 and October 1, 2019

Meeting minutes were approved with the following revisions:

- In September 3 minutes, LaVaida Owens-White attendance was changed from Unexcused to Excused.
- In October 1 minutes, under Director's Updates, Cheryl Heiks name and organization were corrected.

# III. Auditor of Accounts – Kathleen McGuiness – Overview of Auditor's Function

Kathleen McGuinness introduced herself and provided information on her responsibilities. She introduced her Chief of Staff Spiros Mantzavinos. Discussed that the office has a website, social media, etc. and is using more user-friendly technology. Currently benchmarking with other states. Updated training of auditors and is looking for support in updating budget. Currently does not have office space in other counties. Reports can be seen online at FRAUD@delaware.gov. The Auditors Office has been audited by an outside auditor and is making suggested changes. Did the first statewide risk assessment survey. Currently developing risk-based audit code. Now has an app to download on phones to report fraud. Can also anonymously report fraud on the 800-55FRAUD hotline. Working with the Better Business Bureau to work with small businesses to review fraud. Upgrading software that is strong with internal controls. Looking to help other agencies. Is available to speak wherever and whenever needed. Would like to see information brought into senior centers – currently developing a brochure to address the elderly targets of fraud. Also looking to do some town halls to get the information out.

# **IV.** Director's Update

Deputy Director Smith provided the following updates:

- Process of finalizing contract with ADvancing States (formerly NASUAD).
- Older American's Act Amendment review.
- JLOSC APS update. New report due in January.
- Tomorrow (11/6/19) giving a presentation to legislators.
- Generations Home Care day care provider closed their doors. The 11 participants in that contract were able to transfer to other organizations.
- In the beginning stages of the 2020-2024 State Plan on Aging. Looking for a volunteer from the Council to represent our constituents in the Oversight Committee. Ken Bock has volunteered.
- CMP Fund Request for Person-Centered Care 80-85% of staff received basic training in two days so far. Currently collecting data through focus groups to improve. Next will be rolling out specialized training for families/clients, then non-clinical staff, then to medical staff. This is a three-year project.
- Census surveyors are here at DHCI today
  - Delaware Hospital for the Chronically Ill (DHCI): 98
  - o Governor Bacon: 43
