I. Call to Order

The meeting was called to order at 10:02 am by Carolyn Fredericks. A quorum of 9 joined the meeting (two members arrived late). Voice roll call was taken.

II. State Plan on Aging

Laura Howard updated the council on the current State Plan on Aging. It can be found on the DSAAPD site - https://www.dhss.delaware.gov/dhss/dsaapd/ under "Publications and Forms".

III. Director's Update

Public budget hearing is scheduled for November 14, 2018 where Secretary Walker will present the budget. The challenge is meeting projected growth; haven't been asked to make any budget cuts at this time.

Have to look at ERS and PAS individually, depending on needs – has the term "emergency" been defined by DSAAPD? Can we head off by offering services? Assessments are done on each client, but is dependent on if the client wants the service offered. Carolyn requested the number on waitlist and dollar amount. Question on who qualifies for an assessment service. Laura to follow up.

Once February budget hearings are set, staff will send out an email to council so they can advocate.

IV. Advocacy Committee

Ken Bock sent a letter of introduction to all legislators to introduce the committee. He will get a copy out to council after today's meeting. Discussion on who speaks for the homeless. The Delaware State Housing Authority would be in charge of looking for resources for them. Maggie Webb stated veteran's organizations have pushed to end homelessness, although she doesn't think it is funded by the VA. Will bring information to the group. Committee will make a list of areas of focus for advocacy – assisted devices mentioned – something to talk to legislators about what is needed. Grandparents raising grandchildren were mentioned. Come up with mission statement and set up a couple of priorities. Grant-in-Aid is another area of concern; want to monitor what is going on.

Committee set a meeting date for January 8. Would like a copy of the Secretary's presentation from the public budget hearing on anything to do with aging and physical disabilities. Delaware Aging Network has not met with DSAAPD.

Would like to see information regarding the Senior Trust Fund on the March agenda.

Concerns with Managed Care Meals – especially Mom's Meals. They are missing the point of checking in on the clients daily. Laura checked with DMMA and individuals are not often told they can use Title III meal providers, such as Meals on Wheels. There is a major disconnect in communication. MCO has to offer a choice of providers
