

Delaware Weekly Influenza Report Week 49 (December 1 – November 30, 2013) Delaware Division of Public Health

#### National Synopsis 2013 – 2014

National data are updated Friday of each week. Please visit <u>http://www.cdc.gov/flu/weekly/</u> for the most current information. Briefly, influenza activity continues to increase in the United States. Fourteen states reported regional activity; 18 states reported local activity; 16 states and D.C., Guam, and Puerto Rico reported sporadic activity; and 2 states and the U.S. Virgin Islands reported no influenza activity.

Both national and state data are provisional and subject to change as additional reports are received.

#### Delaware Influenza Surveillance 2013 – 2014

There were 8 confirmed cases of influenza reported during week 49. Reports of influenza-like illness (ILI) received from participating providers, facilities, and institutions indicate a relatively low level of ILI in the community. Levels of ILI reported by sentinel providers participating in ILINet were approximately 1.4%, below the regional baseline of 2.0%.

#### Level of Influenza Activity<sup>1</sup> in Delaware, Week 49:

# Sporadic

Small numbers of laboratory-confirmed<sup>2</sup> influenza cases or a single laboratory-confirmed influenza outbreak has been reported, but there is no increase in cases of ILI.

Influenza-like illness (ILI) is defined as patients presenting with fever of 100° F or greater, cough and/or sore throat in the absence of a known cause other than influenza.

**No Activity:** No laboratory-confirmed<sup>2</sup> cases of influenza and no reported increase in the number of cases of ILI.

**Sporadic:** Small numbers of laboratory-confirmed<sup>2</sup> influenza cases or a single laboratory-confirmed influenza outbreak has been reported, but there is no increase in cases of ILI.

**Local:** Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed<sup>2</sup> influenza in a single region of the state.

**Regional:** Outbreaks of influenza or increases in ILI and recent laboratory confirmed<sup>2</sup> influenza in at least two but less than half the regions of the state with recent laboratory evidence of influenza in those regions.

**Widespread:** Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed<sup>2</sup> influenza in at least half the regions of the state with recent laboratory evidence of influenza in the state.

Activity levels may not be comparable across states because some states may use different definitions for lab confirmation of influenza cases. Some states may include rapid diagnostic tests as confirmatory while Delaware considers viral culture or PCR as confirmatory.



<sup>2</sup> Percent positive= (number of specimens PCR positive for flu reported during the week) / (total number of specimens submitted during the week); lab data reflect the date the test result was reported and not the date that the specimen was collected. The percent positive reflects only the percent testing positive for specimens submitted by WHO/NREVSS Collaborating Laboratories in Delaware (includes Christiana Care and the Delaware Public Health Laboratory).





### U.S. Outpatient Influenza-like Illness Surveillance Network (ILINet) (Sentinel) Provider Surveillance Network:


An ILINet (sentinel) provider conducts surveillance of influenza-like illness (ILI) in collaboration with the Division of Public Health and the Centers for Disease Control and Prevention (CDC). Data reported by ILINet providers, in combination with other influenza surveillance data, provide a national and statewide picture of influenza activity in the U.S.

<sup>2</sup> Regional baseline is calculated by CDC using non-influenza weeks from the previous 3 influenza seasons. Delaware is a member of Region 3 and includes DE, DC, MD, PA, VA, and WV. Regional baseline= 2.0%.

<sup>2</sup> % ILI= percentage of residents with ILI symptoms. Eight of 19 LTCFs reported for MMWR 49.


<sup>3</sup> % ILI= percentage of student visits for ILI. Schools reporting include the University of Delaware, Delaware State University, and Wesley College.

**NOTE:** Data provided do not reflect the total number of individuals who have been infected with the influenza virus in Delaware during the reporting period as a result of the following factors:

- Many people ill with influenza-like symptoms do not seek medical care.
- Many who do seek medical care are not tested for influenza.
- The Delaware Public Health Laboratory (DPHL) is limited by capacity to processing a maximum of 3 specimens per day from each reporting entity.
