



Delaware Weekly Influenza Report Week 03 (January 12 – January 18, 2014) Delaware Division of Public Health

National Synopsis 2013 – 2014

National data are updated Friday of each week. Please visit <http://www.cdc.gov/flu/weekly/> for the most current information. Briefly, influenza activity is high the United States and increasing in Delaware. Forty-one states reported widespread activity; 8 states and Puerto Rico reported regional activity; D.C. reported local activity; 1 state and Guam reported sporadic activity; and the U.S. Virgin Islands reported no influenza activity.

Surrounding states in our region reported widespread (PA, MD, VA, and WV) and local (D.C.) influenza activity.

Both national and state data are provisional and subject to change as additional reports are received.

Delaware Influenza Surveillance 2013 – 2014

Overall, the level of flu activity in Delaware is increasing. There were 102 confirmed cases of influenza reported during week 03. Reports of influenza-like illness (ILI) received from participating providers, facilities, and institutions indicate increased levels of ILI in their facilities or population. The level of ILI reported by sentinel providers participating in ILINet was approximately 2.4%, above the regional baseline of 2.0%.

Level of Influenza Activity¹ in Delaware, Week 3

Widespread

Widespread: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed² influenza in at least half the regions of the state with recent laboratory evidence of influenza in the state.

Influenza-like illness (ILI) is defined as patients presenting with fever of 100° F or greater, cough and/or sore throat in the absence of a known cause other than influenza.

No Activity: No laboratory-confirmed² cases of influenza and no reported increase in the number of cases of ILI.

Sporadic: Small numbers of laboratory-confirmed² influenza cases or a single laboratory-confirmed influenza outbreak has been reported, but there is no increase in cases of ILI.

Local: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed² influenza in a single region of the state.

Regional: This level does not apply to Delaware. Per CDC, regional does not apply to states with ≤ 4 regions³.

Widespread: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed² influenza in at least half the regions of the state with recent laboratory evidence of influenza in the state.

¹ Activity levels may not be comparable across states because some states may use different definitions for lab confirmation of influenza cases. Some states may include rapid diagnostic tests as confirmatory while Delaware considers viral culture or PCR as confirmatory.

² Laboratory confirmed case= case confirmed by viral culture or PCR.

³ Region= population under surveillance in a defined geographical subdivision of a state. Regions typically include several counties.

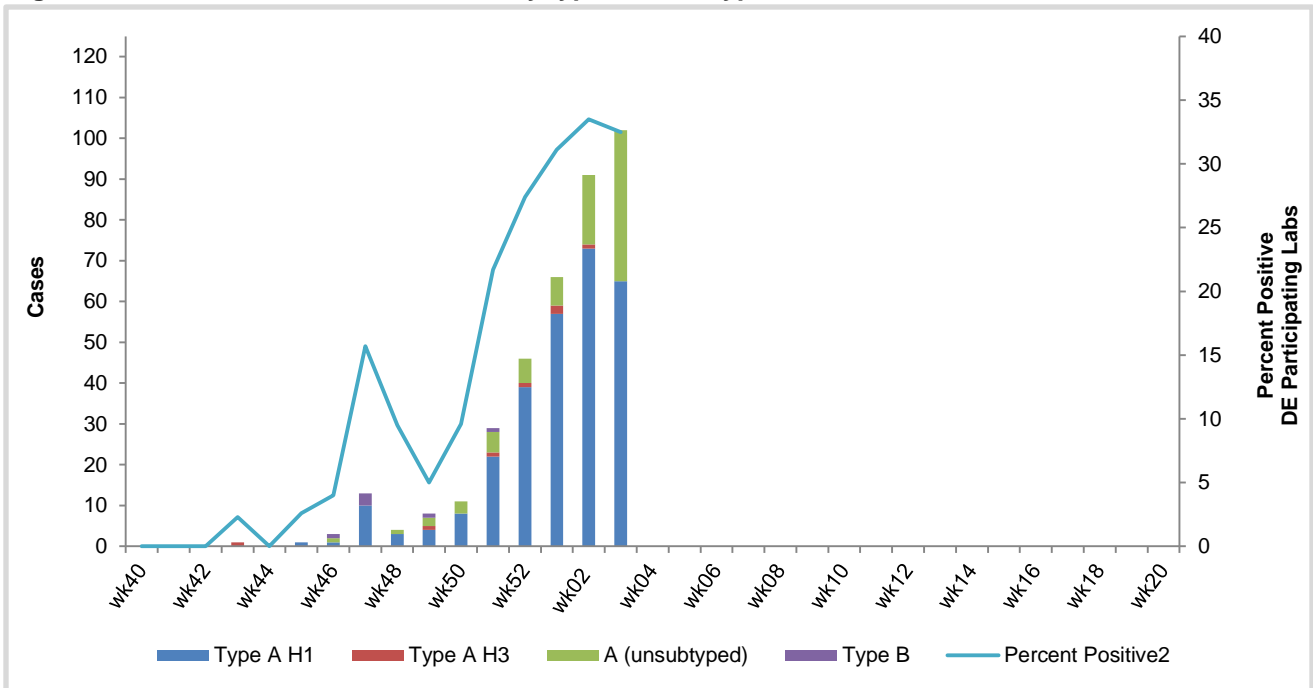

²Reports are by date of specimen collection, not the date the results are obtained. As a result, prior weeks' counts may be adjusted to reflect additional cases received.

¹ Based on patients with positive nucleic acid or viral culture test results reported to the Delaware Division of Public Health. There were 102 confirmed case of influenza reported during MMWR 03. Confirmed cases are reported for the date the specimen was collected; not the data that positive test result was reported; this is different from the percent positive calculation.

² Percent positive= (number of specimens PCR positive for flu reported during the week) / (total number of specimens submitted during the week); lab data reflect the date the test result was reported and not the date that the specimen was collected. The percent positive reflects only the percent testing positive for specimens submitted by WHO/NREVSS Collaborating Laboratories in Delaware (includes Christiana Care and the Delaware Public Health Laboratory). The percent positive does not reflect specimens tested by hospitals not participating in the WHO/NERVSS Collaborating Labs in Delaware.

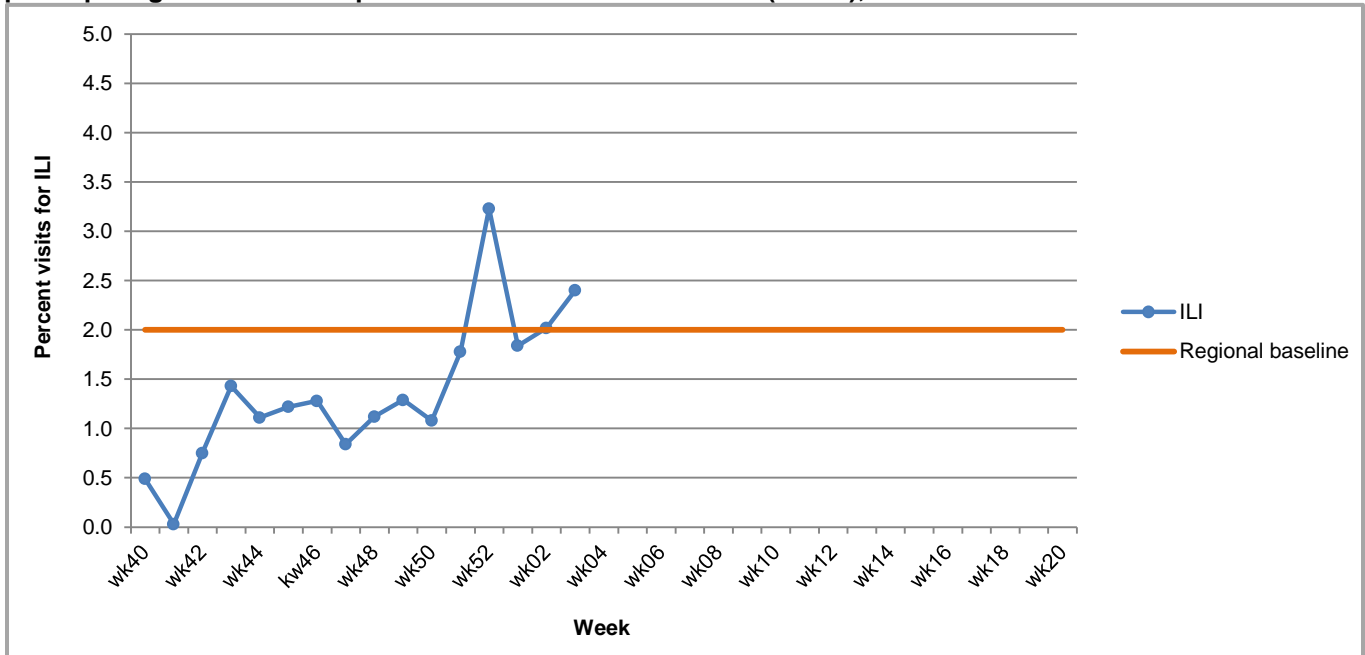

U.S. Outpatient Influenza-like Illness Surveillance Network (ILINet) (Sentinel) Provider Surveillance Network:

An ILINet (sentinel) provider conducts surveillance of influenza-like illness (ILI) in collaboration with the Division of Public Health and the Centers for Disease Control and Prevention (CDC). Data reported by ILINet providers, in combination with other influenza surveillance data, provide a national and statewide picture of influenza activity in the U.S.

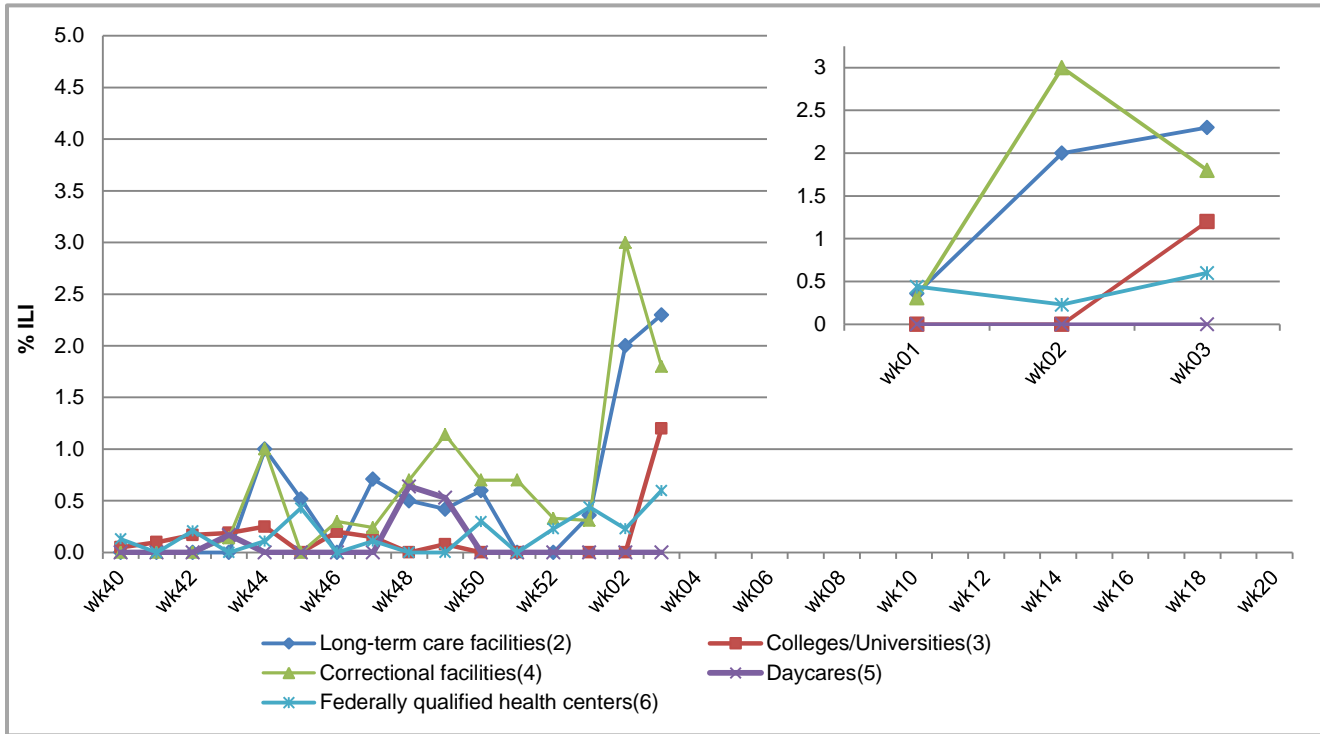
Figure 2. Percentage of visits for influenza-like illness (ILI) reported by sentinel healthcare providers¹ participating in the U.S. Outpatient ILI Surveillance Network (ILINet), Delaware 2013-2014.

² % ILI= percentage of residents with ILI symptoms. Six of 19 LTCFs reported for MMWR 03.

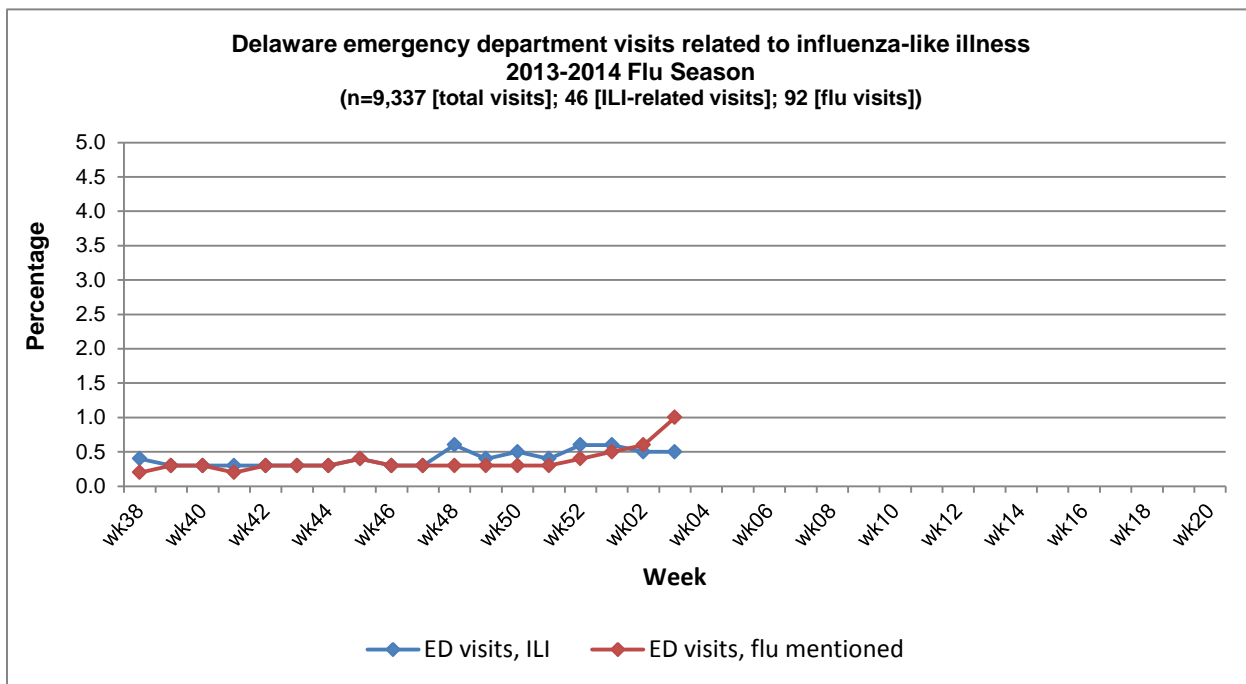
³ % ILI= percentage of student visits for ILI. Schools reporting include the University of Delaware, Delaware State University, and Wesley College.

- The Delaware Public Health Laboratory (DPHL) is limited by capacity to processing a maximum of 3 specimens per day from each reporting entity.
