

Delaware Weekly Influenza Report MMWR Week 4 (January 24 - 30, 2016) Delaware Division of Public Health

National Influenza Synopsis 2015-2016:

National data are updated Friday of each week. Please visit <u>http://www.cdc.gov/flu/weeklv/</u> for the most current information. During MMWR Week 4 (January 24 - 30, 2016) influenza activity continues to increase slightly in the United States. The most frequently identified influenza virus type reported by public health laboratories during week 4 was influenza A, with influenza A (H1N1)pdm09 viruses predominating. The percentage of respiratory specimens testing positive for influenza in clinical laboratories increased. **Widespread** influenza activity was reported by Puerto Rico and three states (California, Iowa and Massachusetts). **Regional** influenza activity was reported by Guam and 18 states (Arizona, Connecticut, Indiana, Kentucky, Maine, Maryland, Nevada, New Hampshire, New Jersey, New Mexico, New York, North Carolina, Rhode Island, Texas, Utah, Vermont, Virginia and Washington). **Local** influenza activity was reported by the District of Columbia and 16 states (Alabama, Alaska, Arkansas, Colorado, Florida, Idaho, Illinois, Michigan, Minnesota, North Dakota, Ohio, Oklahoma, Oregon, Pennsylvania, South Carolina and Wyoming). **Sporadic** influenza activity was reported by the U.S. Virgin Islands and 12 states (Delaware, Georgia, Hawaii, Kansas, Louisiana, Missouri, Montana, Nebraska, South Dakota, Tennessee, West Virginia and Wisconsin). **No activity** was reported by Mississippi. Both national and state data are provisional and subject to change as additional reports are received.

Delaware Influenza Surveillance 2015-2016:

During MMWR Week 4, there were six laboratory-confirmed cases of influenza reported among Delaware residents, with a total of 31 confirmed cases for the 2015-2016 season. Reports of influenza-like illness (ILI) received from participating providers, facilities and institutions in **Delaware show ILI is 0.12%**, (baseline is 1.8%). **Nationally, ILI is 2.2%** (national baseline is 2.1%).

Level of Influenza Activity in Delaware, MMWR Week 4:

Sporadic Small numbers of laboratory-confirmed influenza cases or a single laboratory-confirmed influenza outbreak has been reported, but there is no increase in cases of ILI.

Influenza-like illness (ILI) is defined as patients presenting with fever of 100° F or greater, cough and/or sore throat in the absence of a known cause other than influenza.

No Activity: No laboratory-confirmed cases of influenza and no reported increase in the number of cases of ILI.

Sporadic: Small numbers of laboratory-confirmed influenza cases or a single laboratory-confirmed influenza outbreak has been reported, but there is no increase in cases of ILI.

Local: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in a single region of the state.

Regional: Outbreaks of influenza or increases in ILI and recent laboratory-confirmed influenza in at least two but less than half the regions of the state with recent laboratory evidence of influenza in those regions.³

Widespread: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in at least half the regions of the state with recent laboratory evidence of influenza in the state.

³ Region = population under surveillance in a defined geographical subdivision of a state. Regions typically include several counties. Regional doesn't apply to states with < four counties.




Figure 1. Confirmed cases¹ of influenza by type and subtype/lineage, Delaware 2015-16*



U.S. Outpatient Influenza-Like Illness Surveillance Network (ILINet) Sentinel Providers

An ILINet (sentinel) provider conducts surveillance for influenza-like illness (ILI) in collaboration with the Division of Public Health and the Centers for Disease Control and Prevention (CDC). Data reported by ILINet providers, in combination with other influenza surveillance data, provide a national and statewide picture of influenza activity in the U.S.

² Regional baseline is calculated by CDC using non-influenza weeks from the previous three influenza seasons. Delaware is in Region 3 that includes DE, DC, MD, PA, VA and WV.




Figure 3. Influenza-like illness reported by influenza surveillance ILI reporting partners¹, Delaware 2015-16



Summary of International Influenza Activity

Influenza activity was slowly increasing but still below seasonal expected levels in North America. Respiratory virus activity was at low levels in tropical countries of the Americas, Central America and the Caribbean.

Increasing influenza activity was reported in northern and eastern Europe, with still low activity in western and southern Europe. An increase in severe acute respiratory infections due to influenza A(H1N1)pdm09 was reported from some eastern European countries.

In northern/temperate Asia, influenza activity was ongoing in Mongolia and was increasing in the Republic of Korea. In central and western Asia, influenza activity remained at high levels where Israel, Jordan and Oman reported increased influenza activity, predominantly due to influenza A(H1N1)pdm09 and influenza B viruses. Pakistan also reported elevated influenza activity, predominantly due to influenza A(H1N1)pdm09.

Few influenza virus detections were reported by countries in tropical Africa.

In temperate countries of the Southern Hemisphere respiratory virus activity remained low.

- The Delaware Public Health Laboratory is limited by capacity to processing a maximum of three specimens per day from each reporting entity.
