

National Influenza Synopsis 2017-2018:

National data are updated Friday of each week. Please visit <u>http://www.cdc.gov/flu/weekly/</u> for the most current information. During MMWR Week 6 (February 4 - 10, 2018) influenza activity remained elevated in the United States. The most frequently identified influenza virus subtype reported by public health laboratories during week 6 was influenza A(H3). The percentage of respiratory specimens testing positive for influenza in clinical laboratories remained elevated. <u>Widespread influenza activity</u> was reported by 48 states and Puerto Rico. <u>Regional influenza activity</u> was reported by Oregon. <u>Local influenza activity</u> was reported by the Hawaii, District of Columbia and Guam. <u>No influenza activity</u> was reported by the U.S. Virgin Islands. Both national and state data are provisional and subject to change as additional reports are received.

Delaware Influenza Surveillance 2017-2018:

During MMWR Week 6, there were 1,268 laboratory-confirmed cases of influenza reported among Delaware residents, bringing the total to 4,235 confirmed cases for the 2017-2018 season. Reports of influenza-like illness (ILI) received from participating providers, facilities and institutions in Delaware show ILI is 6.4% compared with Delaware's 2017-2018 baseline of 2.0%. Nationally, ILI is 7.5% compared with the 2017-2018 national baseline of 2.2%.

Level of Influenza Activity in Delaware, MMWR Week 6:

Widespread Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in at least half the regions of the state with recent laboratory evidence of influenza in the state.

Influenza-like illness (ILI) is defined as patients presenting with fever of 100° F or greater, cough and/or sore throat in the absence of a known cause other than influenza.

No Activity: No laboratory-confirmed cases of influenza and no reported increase in the number of cases of ILI.

Sporadic: Small numbers of laboratory-confirmed influenza cases or a single laboratory-confirmed influenza outbreak has been reported, but there is no increase in cases of ILI.

Local: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in a single region of the state.

Regional: Outbreaks of influenza or increases in ILI and recent laboratory-confirmed influenza in at least two but less than half the regions of the state with recent laboratory evidence of influenza in those regions.³

Widespread: Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed influenza in at least half the regions of the state with recent laboratory evidence of influenza in the state.

¹ 2017-2018 Region 3 (DE, DC, MD, PA, VA and WV) baseline = 2.0%.

² Laboratory-confirmed case = case confirmed by viral culture or PCR.

³ Region = population under surveillance in a defined geographical subdivision of a state. Regions typically include several counties. Regional doesn't apply to states with <u><</u> four counties.




Figure 1. Confirmed cases¹ of influenza by type and subtype/lineage, Delaware 2017-18*



U.S. Outpatient Influenza-Like Illness Surveillance Network (ILINet) Sentinel Providers

An ILINet (sentinel) provider conducts surveillance for influenza-like illness (ILI) in collaboration with the Division of Public Health and the Centers for Disease Control and Prevention (CDC). Data reported by ILINet providers, in combination with other influenza surveillance data, provide a national and statewide picture of influenza activity in the U.S.




Figure 3. Influenza-like illness reported by influenza surveillance ILI reporting partners¹, Delaware 2017-18

- 5 % ILI= percentage of children absent with ILI; One daycare provider reported.







Figure 4b. County-specific percentages of ED visits due to ILI/Flu by MMWR Week, Delaware 2017-18



Summary of International Influenza Activity

Worldwide, influenza A accounted still for the majority of influenza detections but influenza B (mostly from the Yamagata lineage) increased in recent weeks.

Up to now, the majority of countries which are in the influenza season, reported influenza like illness reaching moderate levels in comparison with previous years, with few reaching levels exceeding those of previous years. Some countries however have reported levels of hospitalization and ICU admissions reaching or exceeding peak levels of previous influenza seasons. WHO recommends countries with current influenza activity or entering their season to adopt necessary measures for ensuring appropriate case management, compliance with infection control measures and seasonal influenza vaccination for high risk groups.

Influenza activity remained high in the temperate zone of the northern hemisphere while in the temperate zone of the southern hemisphere activity was at inter-seasonal levels.

In North America, overall influenza activity remained high, with detections of predominantly influenza A(H3N2) viruses.

In the Caribbean and Central American countries, respiratory illness indicators and influenza activity remained low in general.

In Europe, influenza activity remained high in Northern and Southwestern Europe, and peaked in few countries but started to increase in Eastern Europe. Influenza B remained the virus most frequently detected and the subtype of the influenza A viruses detected varied depending on the country and the surveillance system.

In Western Asia, increasing influenza activity was reported in some countries, with influenza A(H1N1)pdm09 and B viruses present in the region. In Central Asia, influenza activity increased slightly, although it remained low across the region. In East Asia, high levels of illness indicators and influenza activity were reported in most of the countries. Influenza A(H1N1)pdm09 and influenza B-Yamagata lineage viruses were predominantly detected. In South East Asia, low levels of influenza activity were reported to be high in Iran and Pakistan, with detection of all seasonal influenza subtypes.

In Northern Africa, influenza detections remained high in Algeria, Egypt and Morocco, while decreased in Tunisia. Influenza A(H1N1)pdm09 virus and influenza B were predominantly detected in the region. In Western Africa, little to no influenza activity was reported across the region. In Middle Africa, there were no updates available for this reporting period. In Eastern Africa, increased influenza activity was reported in Madagascar.

In the tropical countries of South America, influenza activity and respiratory illness indicators were generally low, with exception of Ecuador.

In the temperate zone of the Southern Hemisphere, influenza activity remained overall at inter-seasonal levels.
