**Nirav R. Shah, MD, MPH**, is the senior vice president and chief operating officer for clinical operations for Kaiser Permanente's Southern California region, a \$25B health system with over 4.4 million insured members. He is a thought leader in patient safety and quality, the social determinants of health, and the strategies required to transition to lower-cost, patient-centered health care. Dr. Shah is board-certified in Internal Medicine and is a graduate of Harvard College and Yale School of Medicine. An elected member of the National Academy of Medicine, he serves on the HHS Secretary's advisory committee to set the nation's health priorities, Healthy People 2030.



Al Kurose, MD, MBA, FACP is President and CEO of Coastal Medical, a primary care driven Accountable Care Organization (ACO). Coastal Medical provides care to 120,000 patients in 20 medical offices across Rhode Island, and is at the forefront of healthcare delivery system transformation and payment reform, both locally and nationally. Dr. Kurose has led Coastal Medical since 2008, and has been a driving force behind Coastal Medical's transition to accountable care. Dr. Kurose is a graduate of the Washington University School of Medicine in St. Louis, MO, and completed the Brown University Internal Medicine Residency Training Program at Rhode Island Hospital in 1991. He is also a graduate of the Yale MBA for Executives: Leadership in Healthcare program, and a Clinical Assistant Professor of Health Services, Policy & Practice at Brown University.



**Dr. Norvell Vandervall (Van) Coots** is the President and CEO of Holy Cross Health and the President and CEO of the Maryland Region of Trinity Health. Prior to joining Holy Cross Health in 2016, Dr. Coots retired from the Army as a Brigadier General, his final assignment was as Commanding General, Regional Health Command Europe, and as the Command Surgeon for the US Army Europe and 7<sup>th</sup> Army, with his headquarters located in Sembach, Germany. Previous assignments included Deputy Commanding General (Support), US Army Medical Command, and as the Assistant Surgeon General (Force Projection) of the Army, 2013-2014. Dr. Coots is a graduate of the University of Oklahoma College of Medicine. Board-certified in Dermatology, he has a Masters degree in Strategy from the Army War College.



Colleen A. Kraft, MD, FAAP is President-Elect of the American Academy of Pediatrics. She has worked in population health management at Cincinnati Children's and at the Virginia Tech School of Medicine. Dr. Kraft received her undergraduate degree at Virginia Tech and her M.D. from Virginia Commonwealth University. She completed her residency in Pediatrics at Virginia Commonwealth University. Dr. Kraft has worked in primary care pediatrics and was the Founding Pediatric Program Director at the Virginia Tech Carilion School of Medicine. Dr. Kraft has served as the Medical Director for a Medicaid managed care organization in Virginia as well as a Pediatric Accountable Care Organization at Cincinnati Children's Hospital. Dr. Kraft's work in early childhood and population health seeks to translate the goals of health equity into medical practice.



**Sharon L.
