<input type="checkbox"/> Have completed training in an accredited graduate training program	<input type="checkbox"/> Not have breached a prior service obligation
<input type="checkbox"/> Have qualifying educational loans, which are <u>not</u> in default	<input type="checkbox"/> Not have a current default on any Federal payment obligation
<input type="checkbox"/> Possess an active and valid Delaware license	<input type="checkbox"/> Not have a current default on court-ordered child support payments
<input type="checkbox"/> Practice in a HRSA-eligible discipline	<input type="checkbox"/> Not have any federal judgment liens
<input type="checkbox"/> Provide services in a HRSA-qualified public or non-profit facility located in a Health Professional Shortage Area (HPSA)	<input type="checkbox"/> Not had any debt written off as uncollectible
<input type="checkbox"/> Practice full-time (40 hours per week) providing primary health services	<input type="checkbox"/> Not have received a waiver of any Federal service or payment obligation
