#### **EXECUTIVE SUMMARY**

The Delaware Nursing Home Utilization Statistical Report (DNHUSR) is published annually by the Delaware Health Care Commission (DHCC) as a method of reporting trends in Delaware's long-term care and rehabilitation services landscape. The 2023 DNHUSR highlights the ongoing impacts of the COVID-19 pandemic on Delaware nursing home utilization trends.

In 2023, 44 Delaware nursing homes operated a maximum of 4,859 licensed beds. With the exception of the Delaware Hospital for the Chronically III in Smyrna, all licensed nursing homes in Delaware are privately owned and operated. In 2023, Delaware nursing homes collectively admitted 8,193 patients. Although the total number of 2023 admissions remained 31% lower compared to 2019 (i.e., the year immediately prior to the start of the COVID-19 pandemic), admission statistics reflect a partial rebound from pandemic impacts. Across each of Delaware's three counties, a majority of private nursing home admissions represent residents of the county in which the facility is located. In 2023, Sussex County nursing homes had the largest percentage of out-of-state admissions (10.6%) relative to facilities in New Castle County (4%) and Kent County (2%). Nursing home discharge trends closely mirror admission trends across all three counties. In 2023, 54.3% of patients discharged from Delaware nursing homes returned to their own home or a relative's home. One-quarter of discharged nursing home patients were discharged to hospital-based care (25.9%), and 11.6% of all discharges were due to death.

In 2023, females accounted for approximately 60% of all Delaware nursing home admissions and discharges. White patients accounted for 78.8% of nursing home admissions and 79.8% of nursing home discharges in 2023. In the same year, Black patients accounted for 21.1% of nursing home admissions and 20.1% of nursing home discharges. Patients of other races accounted for 2.3% of 2023 nursing home admissions and 2.5% of 2023 nursing home discharges. The racial breakdown of 2023 nursing home admissions and discharges aligns with Delaware's demographic distribution among the 65+ population. Individuals ages 75-84 comprised the largest percentage of 2023 admissions (34.9%) and discharges (34.6%). The youngest category of patients – those under age 65 – accounted for 12.5% of admissions and 9.8% of discharges in 2023.

In 2023, private nursing homes in New Castle, Kent, and Sussex Counties operated at 67.9%, 63.2%, and 60.2% occupancy, respectively. This lower rate should be interpreted with caution, as the lower rate compared to previous years is due to missing 2023 data from three facilities.

The 2023 Delaware Nursing Home Utilization Statistical Report (DNHUSR) was funded by the Delaware Health and Social Services, Delaware Health Care Commission and is the product of collaborative support from the Delaware Health Care Facilities Association, the Division of Services for Aging and Adults with Physical Disabilities, and Delaware nursing homes. The Delaware Health Care Commission thanks these stakeholders and other subject matter experts who provided background information, analysis, and feedback to inform the development of this report.

#### INTRODUCTION

This, the 37<sup>th</sup> edition of the Delaware Nursing Home Utilization Statistical Report (DNHUSR), summarizes Delaware nursing home trend data for January through December 2023. Data summarized in the DNHUSR are submitted on a monthly basis by Delaware nursing homes<sup>1</sup>, and aggregated at the end of the reporting year to yield annual trend data by nursing home facility and county. The DNHUSR presents 2023 Delaware nursing home data in two main sections.

- Part 1 of the report (Delaware Nursing Home Utilization Statistics) summarizes data from 2013 through 2023 and provides a high-level view of nursing home utilization trends in Delaware over the past decade. Data presented in Part 1 are aggregated to the state- and county-levels.
- Part 2 of the report (Facility-Level Nursing Home Utilization Statistics) presents facility-level data, including total patient days, occupancy rates, percentage of patients by source of payment, and annual admissions and discharges. Part 2 of the DNHUSR provides a more detailed view of utilization trends among Delaware's licensed nursing homes.

The 2023 DNHUSR reflects the ongoing impacts of the COVID-19 pandemic on Delaware nursing home utilization trends. Since 2020, the COVID-19 pandemic has profoundly impacted nursing homes and other long-term care facilities across the U.S. Delaware's total number of nursing home admissions in 2023 (8,193) partially rebounded from the previous low of 2020 (8,538) but remained 30% lower than pre-pandemic values. From 2022 to 2023, the aggregate occupancy rate for private Delaware nursing homes decreased from 76.5% to 68.0% possibly due to facilities' missing data. Future iterations of the DNHUSR will continue to quantify the long-term impacts of the COVID-19 pandemic on nursing home utilization trends.

#### STATEWIDE POPULATION PROJECTIONS

Population growth is central to understanding Delaware's nursing home utilization trends and future nursing home bed need. DHCC analyzed 2023 Delaware Population Consortium data to provide the context within which to evaluate Delaware's ability to meet nursing home bed demand.





Figure 1: Delaware Population Projections (2020-2050), Overall Population, by County

**Total Population Growth.** Between 2020 and 2050, Delaware's total population is expected to increase 18.0%, rising from 989,948 to 1,167,866 (Figure 1). The anticipated growth in total population is distributed unevenly across Delaware's counties. While the total population of New Castle County is expected to increase 3.8% from 2020

comprehensive and individualized treatment and rehabilitation services to promote functional status and independence.

to 2050, the expected rate of population growth in Delaware's other two counties is more pronounced. From 2020 to 2050, total population is expected to increase 17.6% in Kent County and 52.3% in Sussex County.

Population Growth Among the 65+ Population. Projected population growth continues to be more dramatic among older Delawareans (Figure 2). From 2020 to 2050, the population of Delawareans ages 65 and older is expected to increase 40.1%, rising from 194,577 to 272,782. The expected rate of population growth increases with age. From 2020 to 2050, the number of Delawareans ages 65-69 and 75-79 is projected to increase 0.5% and 0.0%, respectively. The number of adults ages 75-79 and ages 80-84 is expected to increase 31.5% and 102.2%, respectively. In comparison, the number of Delawareans ages 85+ is expected to increase 233.5% from 2020-2050 (Figure 2).

#### PART 1: 2023 DELAWARE NURSING HOME UTILIZATION STATISTICS

#### 2023 NURSING HOME FACILITIES AND LICENSED BEDS

In 2023, 44 Delaware nursing homes operated a maximum of 4,859 licensed beds (Table 1). With the exception of the Delaware Hospital for the Chronically III in Smyrna, all licensed nursing homes in Delaware are privately owned and operated. Throughout 2023, the total number of licensed nursing home beds in use at any one time fluctuated due to facility closures and increases and reductions in licensed bed counts.

#### 2023 NURSING HOME ADMISSIONS






Figure 3: Delaware Nursing Homes, Total Number of Nursing Home Admissions, 2013-2023, by Facility Type and County

In 2023, Delaware nursing homes collectively admitted 8,193 patients (Table 2; Figure 3). Although the total number of 2023 admissions remained 31% lower compared to 2019 (i.e., the year immediately prior to the start of the COVID-19 pandemic), admission statistics reflect a partial rebound from pandemic impacts. In New Castle County, nursing home admissions decreased 9% from 2022 to 2023. Sussex County facilities experienced a 22% decrease in total admissions from 2022 to 2023. In Kent County, total admissions to nursing homes declined 33% from 2022 to 2023. Annual admissions to Delaware public nursing homes have historically fluctuated due to facility closures and/or reductions in the number of available licensed public nursing home beds. In 2023, four patients were

admitted to Delaware's sole public nursing home facility, Delaware Hospital for the Chronically III.

Limitations exist in data throughout the report, as three facilities, Wilmington Nursing and Rehab (New Castle), The Center at Eden Hill (Kent), and the Seaford Center (Sussex) did not provide any 2023 data. This affects weighted utilization estimates, as well as admission and discharge percentages.

Patient Residency Status. Across each of Delaware's three counties, a majority of private nursing home admissions represent residents of the county in which the facility is located (Figure 4). For example, in 2023, 89.3% of all admissions to New Castle County nursing homes represented New Castle County residents. Similarly, in 2023, 77.7% of admissions to Kent County nursing homes represented Kent County residents, and 78.3% of admissions to Sussex County nursing homes represented Sussex County residents. Sussex County nursing homes had the largest percentage of out-of-state admissions (10.0%) relative to facilities in New Castle County (5.9%) and Kent County (1.2%).

#### 2023 NURSING HOME DISCHARGES

In 2023, Delaware nursing homes discharged 7,564 patients (Table 3; Figure 5). Discharge trends closely mirror admission trends across all three counties. In New Castle County, nursing home discharges decreased 6% from 2022 to 2023. Sussex County facilities experienced a 19% decrease in discharges from 2022 to 2023. In Kent County, discharges from private nursing homes declined 45% from 2022 to 2023. Although the total number of 2023 discharges remained 33.3% lower compared to 2019 (i.e., the year immediately prior to the start of the COVID-19 pandemic).




Figure 6: Delaware Nursing Homes, Total Number of Nursing Home Discharges, 2023, by Destination

Patient Discharge Destination. In 2023, over half (54.3%) of patients discharged from Delaware nursing homes returned to their own home or a relative's home (Figure 6). 25.9% of discharged nursing home patients were discharged to hospital-based care, and 11.6% of all discharges were due to death. Smaller proportions of patients discharged from Delaware nursing homes moved to an assisted living facility (4.0%), another long-term care facility (2.6%), or another destination (1.2%).

#### 2023 NURSING HOME PATIENT DEMOGRAPHICS


Figure 7: Percentage of Delaware Nursing Home Admissions and Discharges, by Patient Sex, 2023

**Patient Sex.** In 2023, females accounted for approximately 60% of all Delaware nursing home admissions and discharges (Figure 7). Females accounted for 4,753 of 8,193 nursing home admissions and 4,413 of 7,564 nursing home discharges.

Patient Race. White patients accounted for 78.8% of nursing home admissions and 77.4% of nursing home discharges in 2023. In the same year, Black patients accounted for 21.1% of nursing home admissions and 20.1% of nursing home discharges. Patients of other races accounted for 2.3% of 2023 nursing home admissions and 2.5% of 2023 nursing home discharges. The 2023 racial breakdown of nursing home admissions and discharges aligns with Delaware's demographic distribution. The Delaware Population Consortium estimates that in 2023, White residents accounted for 78.7% of Delaware's 65+ population, the cohort most likely to utilize nursing home and rehabilitation services.


Figure 8: Percentage of Delaware Nursing Home Admissions and Discharges, by Patient Age, 2023

Patient Age. The overwhelming majority of patients admitted to and discharged from Delaware nursing homes in 2023 were aged 65 or older (Figure 8). For both admissions and discharges, individuals ages 75-84 comprised the largest patient cohorts; patients ages 75-84 accounted for 34.9% of admissions and 34.6% of discharges from Delaware nursing homes in 2023. The youngest category of patients – those under age 65 – accounted for 12.5% of admissions and 9.8% of discharges in 2023.

In general, Black patients and patients of other races admitted to and discharged from Delaware nursing homes tended to be younger compared to White patients. Among Black patients and patients of other races, 19.8% and 32.3% of nursing home admissions represented individuals under the age of 65. In comparison, 10% of White patients admitted to Delaware Nursing Homes in 2023 were under the age of 65. Discharge statistics mirror admission statistics in terms of patient race and age. Among Black patients and patients of other races discharged from Delaware nursing homes in 2023, 20.0% and 20.8% were under the age of 65, respectively. In comparison, 9.5% of all White patients discharged from Delaware nursing homes in 2023 represented individuals under the age of 65.

Patient Source of Payment. In 2023, a majority (67.0%) of Delaware Nursing Home patients used Medicaid as their primary source of payment (Figure 9). Smaller proportions of Delaware nursing home patients utilized Medicare (14%) and Self-Pay (14%) as primary sources of payment in 2023. In 2023, approximately 5% of all nursing home patients used a different source payment source for their care.

#### 2023 NURSING HOME BILLABLE PATIENT DAYS

A commonly used measure of nursing home utilization is the number of billable patient days generated by a facility over a given time period. A billable patient day represents a unit of time (i.e., one day) during which the facility's services are used by one patient. For example, if a nursing home has 100 patients on a specific day, the facility has generated 100 billable patient days for that 24-hour period. If a facility's number of billable patient days increases from one time period to the next, it is an indication that the facility is (a) caring for more patients, (b) caring for patients for longer periods of time, or (c) a combination of these two factors.




Figure 10: Delaware Nursing Homes, Number of Billable Patient Days Utilized by Year, Facility Type, and County, 2013-2023

From 2013-2019, annual billable patient days for private facilities in all three counties remained relatively stable (Table 4; Figure 10). From 2019-2021, billable patient days declined across New Castle, Kent, and Sussex Counties amid the COVID-19 pandemic. From 2021-2022, billable patient days for private nursing home facilities increased across all three Delaware counties (4.2% increase for New Castle County facilities, 2.2% increase for Kent County facilities, and 3.7% increase for Sussex County facilities); these data suggest a partial bounce-back in Delaware private nursing home metrics following the COVID-19 pandemic. In contrast, billable patient days in public facilities have steadily declined from 2013-2023. From 2022-2023, patient billable days have declined. Missing data from three facilities, one in each county, contribute to declines in reported billable days for 2023.

#### 2023 NURSING HOME OCCUPANCY RATES

Occupancy rates are helpful for putting facilities' utilization data within the context of available resources. A facility's occupancy rate reflects the percentage of available beds occupied by patients throughout the reporting year. Occupancy rates are weighted based on the number of days a facility was open during the reporting year. Mathematically, Occupancy Rate = [(Number of Billable Patient Days) / (Number of Licensed Bed Days)] \* 100% where (Number of Licensed Bed Days) equals the sum of the monthly number of licensed bed days in a facility (calculated as number of licensed beds multiplied by number of days in the month). If a facility was open fewer than 12 months, occupancy rate reflects the percentage of available beds occupied by patients during the months in which the facility was open.

In 2023, private nursing homes in New Castle, Kent, and Sussex Counties operated at 67.9%, 63.2%, and 60.2% occupancy, respectively (Table 5; Figure 11).<sup>3</sup> In the decade prior to the COVID-19 pandemic (i.e., from 2013-2019), occupancy rates for private nursing homes consistently approached or exceeded 90%. Occupancy rates for private nursing homes in New Castle, Kent County, and Sussex County decreased from 2022 to 2023, reflecting an overall occupancy rate of 69.4%.

This lower rate reflects missing data from three facilities, one in each county. Wilmington Nursing and Rehab (New Castle), The Center at Eden Hill (Kent), and the Seaford Center (Sussex) did not provide any 2023 data. The number of licensed beds for each facility remained in the equation but billable days were not included. However, this created a lower weighted occupancy rate.



## **APPENDIX A**

## 2023 NURSING HOME UTILIZATION AMONG THE UNDER 65 POPULATION

Beginning with the 2019 DNHUSR, the DHCC began collecting cohort-specific admissions, discharge, and billable patient days data on the Under 65 nursing home patient population. Prior to the 2019 annual report, data pertaining to this cohort were consolidated in an Under 65 category. Currently, Delaware nursing homes report monthly utilization data for populations age 18-34, 35-44, 45-54, and 55-64, and the DHCC uses these data to track nursing home utilization metrics among younger populations.

In 2023, patients under the age of 65 accounted for 1,027 of 8,193 (12.5%) nursing home admissions and 892 of 7,564 (11.7%) nursing home discharges. The largest percentage of nursing home patients under the age of 65 represented adults ages 55-64. Patients ages 55-64 represented 73.1% of nursing home admissions and 77.4% of nursing home discharges among the Under 65 population. Females accounted for 37.0% of nursing home admissions and 36.9% of nursing home discharges among the Under 65 population in 2023. In the same year, White patients accounted for 61.4% of nursing home admissions and 62.3% of nursing home discharges among the Under 65 population. In 2023, of the 41 reporting Delaware nursing homes, 75% (33 of 41) admitted at least one patient under the age of 65.
