### DIMER BOARD PROPOSED LEGISLATIVE CHANGES

#### **Chair and Vice-Chair**

- DIMER Chair will be elected from the board by the board. Chair will serve a 3-year term, no more than 3 terms and non-consecutive.
- DIMER Vice Chair nominated in the same fashion as Chair and with the same term limit rules. This will allow for a successor to Chair.
- A nominating committee will be established for both Chair and Vice Chair position
