CALL TO ORDER

It was determined a quorum was present, and Dr. Fan called the meeting to order at approximately 9:04 a.m. via WebEx. Dr. Fan asked public attendees to virtually sign-in by placing their name and affiliation in the chat box or by sending an email to the DHCC Resource Account (dhcc@delaware.gov).

BOARD BUSINESS

POLICY DEVELOPMENT

Primary Care Physicians in Delaware 2021

Tibor Tóth, Ph.D. Assistant Professor with the Biden School of Public Policy and Administration, presented a summary of the Delaware Primary Care Physicians Survey 2021. This is the 10th time this survey has been conducted and the main goal of this study is to provide input into the shortage area designations for the State of Delaware. The survey was conducted in the middle of the COVID pandemic in 2021 and was published at the end of 2022. The study population is primary care physicians providing direct patient care in the State of Delaware. For the survey, a list of about 6,000 active licensed physicians was obtained from the Division of Professional Regulation some of which were duplicate licenses. 2,687 licenses were contacted. Roughly 2,480 are physicians who have addresses in the State of Delaware. Only 800 responses came in, 150 were non reachable. This is a response rate of about 30%. In 2021, 865 primary care physicians were practicing in the state of Delaware with 660 full-time equivalent (FTE).

At the conclusion of his presentation, Dr. Tóth asked if there were any questions. Dr. Fan asked what his thoughts were about the number of people who participate in the survey and how can we make that more robust? Dr. Tóth stated in the response rate does have an impact on the response error. In this case, there is not a sampling error, but a response error. 30% is reasonable and would like to have a 100% response rate. There are conversations around how to make this survey mandatory during licensing.

Nick Moriello commented the DHCC Workforce Subcommittee has also discussed attaching survey to licensure and considering policy recommendations to share with the Health Care Commission.

Secretary Rick Geisenberger asked how long it takes to complete the survey. Dr. Tóth stated it is a paper survey with about 55 questions and should take on average ten minutes to complete. Secretary Geisenberger asked why Survey Monkey or email was not used. Dr. Tóth shared a pre letter is sent first and then several mailings along with the survey. Follow-up reminder cards are then sent. The paper-based survey is sent to the practice and typically opened by front desk staff that hands it off to the physician. Dr. Tóth has found the paper survey is a better way to reach physicians because emails are more likely to be deleted or overlooked in an inbox. Secretary Geisenberger asked if there were any conclusions drawn as to what drew a provider to Delaware (residency, job, marriage, etc)? Dr. Tóth stated that is something he does not capture, but if there is certain information needed, connect with the Division of Public Health to

request the data and he can do tabulations of that information. Dr. Jan Lee added a question could be added to the survey such as, “What made you decide to practice in Delaware?” Dr. Fan commented that she thinks personally it is an inherent bias that older people take paper surveys, and that the younger population are not going to take a paper survey. Also, adding mandatory questions to licensure might give us a bit more information.

Dr. Harrison asked about the map, New Castle has a mix of green and then right around New Castle was a lot of red, why is there such a contrast of physician representation in that area? Dr. Tóth stated it’s a combination of where physicians choose to provide care, choose to live, and where the population is. Dr. Toth sees a greater concentration of physicians around Foulk Road in North Wilmington and population density. Secretary Geisenberger followed up on Dr. Harrison’s question as it relates to the contrasting information in New Castle County. Many doctors have more than one practice site and how does that get counted in the survey? Dr. Tóth replied that with those physicians having more than one location, it is hard to set questions to cover multiple practice locations and recognized that is missed data. Rich Heffron commented there are these clusters because at one time, physicians used to have offices in their homes and there is more than one physician in the same building.

Steven Costantino asked if the survey asks how many practices are hospital based or office based? Dr. Tóth stated there are specific questions that ask about the practicing facility site for example clinical care setting, federal health facility, school-based, etc. Mr. Costantino asked if there is variation in salary and benefits in the three counties? Dr. Tóth stated the survey does not ask about benefit packages.

Dr. Lee added she thought specialists are more likely to be working out of multiple locations than primary care providers. Dr. Fan shared primary care providers that have more than one location are typically pediatricians and OB-GYN physicians. Dr. Fan suggested a question could be asked on a future survey, how much (percentage) of your practice is spent at your primary care location?
