Health Care Benchmark Summits

- HJR7 directs the DHSS Secretary to begin planning for implementation of a health care benchmark in FY18 and to engage stakeholders in the process
- DHSS is planning a series of Health Care Spending Benchmark Summits in coordination with various stakeholder organizations
- Inaugural summit is today (Sept. 7) from 11:00am 1:00pm and is being cohosted by the Delaware Center for Health Innovation

DCHI Committee Updates

Clinical Committee:

- Pursuing coordination with Delaware Quality of Life Coalition to advance education and focus on palliative and end of life planning/care as a critical component in the continuum of care for patients and consumers
- Aligning efforts with DHIN to ensure support for enabling IT to further health care delivery transformation
- Revisiting research re: Delawareans access to primary care providers and facilitating discussion on the topic during September Committee meeting

Workforce and Education Committee:

- Pursuing resources and partners to continue the effort to streamline the provider licensing and credentialing process
- Released report on Development and Deployment of Community Health Workers in Delaware; partnering with state officials to advance the recommendations

DCHI Committee Updates

Healthy Neighborhoods:

- Smyrna/Dover Local Council
 - Launched with 16 engaged community members from broad sectors of interest;
 now actively engaged in developing infrastructure for the Council. Dover/Smyrna
 Taskforces for Behavioral Health and Healthy Living will launch in Sept.
- Wilmington/Claymont Local Council
 - Chronic Disease and Healthy Lifestyle Taskforces are pursuing an opportunity to implement their first community-level intervention to address social determinants of health
 - CHNA North is pursuing a pilot to address food insecurity in targeted Wilmington areas
 - Collaboration is underway between the LC and CareLink to align community and clinical resources for education for better management of high-risk diabetic patients
- Western Sussex Local Council
 - Integrating CHNA South strategies with 3 LC committees.
 - Engaging with hospitals to increase awareness of need for developmental screenings, developing resource listings for physicians around diabetes and nutrition services, and partnering with Healthier Sussex to address emerging need around Neonatal Abstinence Syndrome babies, as well as the opioid addiction crisis
