1115 Waiver Renewal (2024–2028)

In May 2024, DMMA was **approved for 5-year extension** that addresses Self-Directed Attendant Care (SDAC) and Pediatric Respite programs.

School-Based Services Grant

In July 2024, DMMA received \$2.5 million grant from the Centers for Medicare & Medicaid Services (CMS) to expand school-based services in collaboration with Delaware's Department of Education.

- Evaluate the structure, composition, and goals of CMCAC including review of the "parking lot", a collection of topics of interest initiated in 2020
