Fiscal Year 2025 Recommendations

On behalf of the Delaware Health Fund Advisory Committee (HFAC), I present you with our Fiscal Year 2025 (FY25) Health Fund Recommendations. The Committee's final decisions reflect several hours of discussion and a commitment to sustainable stewardship of the fund.

The State anticipates receiving approximately \$25,000,000.0 in Tobacco Settlement Funds, including principal payment and interest, for FY25. The available Reserve balance is \$15,983,900.0. Funds available total to \$40,983,900.0.

The Committee's FY25 recommendations are as follows:

- Switch-fund the below state programs at their FY25 requested amounts;

  - o Respite Services (DHSS DDDS)
  - o Personal Attendant Services Program (DHSS DSAAPD)
  - Social Security Income Supplement (DHSS DSS)

  - Health Care Connection (DHSS DPH)
  - o Diabetes and Heart Disease Prevention and Control Program (DHSS DPH)

  - o DHSS Library (DHSS)
  - o Social Determinants of Health (DHSS DMMA)

- Switch-fund 20% of Delaware Technical Community College's (DTCC) New Nurse Formation Program FY25 requested amount.
  - o Requested amount: \$3,221,000.0
  - o Recommended HFAC funding: \$2,576,800.0
  - o Recommended switch-funding amount: \$644,200.0
- Fund the Division for Public Health (DPH) Bureau of Health Equity's new program, Health Equity Webinars at 50% of its FY25 requested amount.
  - o Requested amount: \$10,000.0
  - o Recommended HFAC funding: \$5,000.0
  - o Recommended switch-funding amount: \$5,000.0
- Fund the new program, Health Literacy Council of DE/United Way at 50% of its FY25 requested amount, with the understanding funds will go towards cancer and tobaccorelated literacy.
  - o Requested amount: \$400,000.0
  - o Recommended HFAC funding: \$200,000.0
  - o Recommended switch-funding amount: \$200,000.0
- Do not fund DPH's Sexually Transmitted Disease Program.
- Prioritize the Innovation Fund again this year by allotting \$1,500,000.0 in order to provide the State continued flexibility to respond to emerging health trends in our communities.
- Fund remaining programs at their requested FY25 amounts.

The Committee remained cognizant of the continued decrease in funds from the Master Settlement Agreement (MSA) when making funding recommendations for FY25. In addition to the continued decrease in tobacco useage through preventative action at the state level, the Committee remained aware of federal efforts to curb tobacco use. The US Food and Drug Administration (FDA) continues to pursue the ban of menthol cigarettes, and if approved, the Committee expects an even larger decrease of funds and the need to continually make programmic cuts.

Last year, the Committee voted to create a subcommittee to review and revamp the application to further support sustainability as funds continue to decrease. The subcommittee met and a revamped application was accepted by the full committee and used this application cycle. The revamped application reiterates and expands on the focus and background of the fund, and adds questions about future funding and sustainability, community impacts, and health equity.

By way of background on the switch-fund request, in 2009 and 2010, as the country was experiencing a significant recession, the State switch-funded programs from the general fund to the Tobacco Settlement Fund to ensure a balanced budget and to limit cuts to services and programs. Based on conversations with the Office of Management and Budget (OMB), many programs have since been switched back to general funds, however some Department of Health and Social Services (DHSS) programs remain.

During the FY24 cycle, the Committee recommended numerous programs be switch-funded.

This recommendation was not accepted, and seven million additional dollars were funded through the Tobacco Settlement Fund. This consequently cut into the reserves balance and the longevity of the fund.

The Committee's switch-fund recommendations are not intended to communicate that these programs should not be funded; to the contrary, the committee feels strongly that they should be funded, but from the general fund or other funds; not the Tobacco Settlement Fund. By switch-funding identified programs back to general funds, this will increase the continuation of the Tobacco Settlement Fund, and support their distribution to programs aligned with HFAC's mission, per the enabling legislation.

With decreased funding in mind, the committee recommends and underscores the importance of keeping the reserve balance at a healthy amount and strongly recommends the Governor's Office and Office of Management and Budget (OMB) move forward with switch-funding identified programs. Additionally, the Committee encourages DHSS to review programs being recommended for switch-funding and encourages the Department to include these programs in their operating budget requests.

The details of this recommendation are set forth more fully in the attached document. The recommendation expends \$23,204,300.0 leaving \$17,779,600.0 in the Reserve in anticipation of future years of decreased funds.
