Fiscal Year 2022 Recommendations

On behalf of the Delaware Health Fund Advisory Committee (HFAC), I present you with our Fiscal Year 2022 (FY22) Health Fund Recommendations. The Committee's final decisions reflect several hours of discussion.

The State anticipates receiving \$27,000.0 in Tobacco Settlement Funds for FY 22. This amount includes the principal payment and interest as well as a time-limited settlement amount. The State will no longer receive the settlement payment after FY 22. The available Reserve balance is \$4,256.9.

The FY 22 recommendations of HFAC are as follows:

- The Committee recommends switch-funding certain DHSS programs to DHSS's base budget, including keeping Behavioral Health programs as part of the DHSS base budget instead of switch-funding them to the Tobacco Funds.
- The Committee recommends funding all other programs at their FY 21 budget amount, unless the FY 22 requested amount is lower or they received \$0.0 in FY 21.
- HFAC recommends that the Innovation Fund and Social Determinants of Health program continue to be prioritized.
- The Committee recommends moving the remaining \$2,444.4 to the Reserve to prepare for future decreases in funding.

During their meetings, the importance of maintaining funding levels for Smoking Cessation/Prevention and Cancer Programs was brought up several times by HFAC members. This work is at the heart of the Tobacco Master Settlement Agreement and the source of this revenue. Though traditional cigarette usage is declining, usage of e-cigarettes and vaping have increased. There is a misconception, particularly among youth, that e-cigarettes are not as harmful as regular cigarettes. Nationwide, there has been a concerning increase in vaping-related illness and death. Level funding for tobacco prevention education, smoking cessation, and cancer programs must be allocated to ensure Delaware is able to adequately respond to this challenge.

HFAC Recommendations November 13, 2020

HFAC recommends continuing to support the Health Innovation Fund for the purpose of funding health-related programs, including targeted efforts to reduce e-cigarette and vaping among teens. HFAC received updates on funded projects this year, its first full year since its funding in the FY 20 budget, which included projects to help communities handle increased needs and social determinants of health caused by the pandemic. HFAC encourages continued financial support of the Innovation Fund in the FY 22 budget. The Health Innovation Fund allows the State to respond to emerging trends, and therefore, enhances Delaware's ability to address current and future health issues in the state in new and creative ways, and allows for the leverage of funding from community partners along with Health Funds.

This is the first year where the Health Fund is projected to receive considerably less funding than in previous years. The Committee expects this trend to continue in subsequent years, particularly since FY 22 is the final year the Health Fund will receive the additional settlement money. Additionally, the switch funding of programs that occurred during the Great Recession has significantly depleted reserve funding. With these issues in mind, the Committee is preparing to make difficult decisions in upcoming years, including by adding to the Reserve balance this year. The Committee noted that while all programs funded by the Health Fund are valuable, smoking prevention/cessation and cancer programs are the core programs for this Fund and must be prioritized. Non-core programs should work to identify alternative funding sources to ensure there is no service disruption. The Committee heard public comments from many organizations detailing how devastating significant Health Fund cuts would be to their programs, especially during a global pandemic. Severe cuts were able to be avoided this year due to some leftover funds in the Delaware Prescription Assistance Program (DPAP) as well as the proposed switch-funding of core DHSS programs back to DHSS's base budget, but subsequent FY's will continue to be challenging as the Health Fund depletes.

The details of this recommendation are set forth more fully in the attached document. The recommendation expends \$24,055.6, moving \$2,944.4 to the Reserve balance in preparation for future years of decreased funds.
