To determine the percent of enrollees who dropped group health insurance without good cause in order to gain eligibility for DHCP, the Division of Medicaid and Medical Assistance will generate annual reports to compare the number of individuals under age 19 that were denied due to another insurance, reapplied and were approved for DHCP who no longer report other insurance within a six (6) month time frame. If substitution exceeds ten (10) percent, the department will collaborate with CMS to identify a strategy to reduce substitution.
