AuthentiCare Training Descriptions

Course	Who Should Attend	
Aggregator Workshop	Providers who are using their own 3rd party EVV system should attend the Aggregator workshop	
FMSA Training	FMSA staff who will be using the AuthentiCare solution or supporting workers and/or providers who do	
MCO Training	MCO staff who will be using the AuthentiCare solution to review authorizations, visit and claims data and reports	
Provider Training	Fiserv will train Provider Agency EVV Admin staff up to 3 people per agency, on how to utilize the AuthentiCare web portal for Reports, Claims and other applicable processes	
Training for Trainers	For providers using AuthentiCare as their EVV solution. Trainers and individuals identified as responsible for training others within their agency or worker staff. Training focuses on using the AuthentiCare mobile application and IVR.	
Aggregator- Only	Providers with an existing system using AuthentiCare Aggregator	
AuthentiCare Provider	Only. Training focuses on activities providers may need to	
Training	perform within AuthentiCare.

Worker Spreadsheet

- All providers must have their direct service workers uploaded into AuthentiCare.
- Providers have two options to accomplish this:
 - Manually enter information directly into AuthentiCare (this may a good option for providers with relatively few direct service workers)
- Complete the EVV Worker Spreadsheet for all direct service workers and send to AuthentiCare
 - @AuthentiCareAggregatorSupport@firstdata.com
 - Fiserv will then upload the information on the providers behalf

EVV Services Crosswalk

- Providers who are not using AuthentiCare as their EVV Solution need to use the Service Identifier Number rather than the Procedure Code when entering visits.

Testing and Production Credentials

- All providers who are using AuthentiCare as their EVV solution will receive their production credentials prior to go-live.
 - As part of that process, providers will be given the MCDID# that should be used in the system.
- Providers using a 3rd Party EVV Solution will receive their production credentials close to go live.
- Providers using 3rd Party Systems who are interested in testing their uploads of visit data may do so and may request testing credentials by contacting Fiserv at: AuthentiCareAggregatorSupport@firstdata.com
