ATTENTION PLUMBERS

All Commercial Plumbing Applications must undergo Plan Review. All Commercial Plumbing Applications must be submitted to the Office of Engineering via email to DHSS_OE@delaware.gov or via mail to 43 South DuPont Highway, Dover, DE 19901. Once a Plan Review has been conducted, an Approval to Construct (ATC) number will be issued and returned to the applicant.

An ATC is required for a Commercial Plumbing Permit to be issued.

Please submit one (1) fully completed application and one (1) set of plans displaying all fixtures for Plan Review. Extra plan pages such as structural or architectural plans are not required for our review and may delay review times. Please be advised that plans are reviewed on a firstcome first-serve basis and will take some time. Please plan accordingly and leave adequate time in the project planning phase.
