

### Delaware Weekly Influenza Report Week 18 (April 27 – May 3, 2014) Delaware Division of Public Health

#### National Synopsis 2013 - 2014

National data are updated Friday of each week. Please visit <a href="http://www.cdc.gov/flu/weekly/">http://www.cdc.gov/flu/weekly/</a> for the most current information. Influenza activity continued to decrease in the United States, during week 18(ending May 3, 2014). Four states and Guam reported widespread activity; two states reported regional activity; 8 states reported local activity; the District of Columbia, Puerto Rico and 32 states reported sporadic activity; the U.S. Virgin Islands and four states reported no influenza activity.

Surrounding states in our region reported sporadic (D.C., PA and WV); local (VA and MD) influenza activity.

Both national and state data are provisional and subject to change as additional reports are received.

#### Delaware Influenza Surveillance 2013 - 2014

There were 37 confirmed cases of influenza reported during week18 and the level of influenza activity was designated "Sporadic" based on available data. The rates of influenza like illness (ILI) reported by sentinel providers was 0.058%, well below the regional baseline of 2.0%.

#### Level of Influenza Activity<sup>1</sup> in Delaware, Week 18

## **Sporadic**

Small numbers of laboratory-confirmed influenza cases or a single laboratory-confirmed influenza outbreak has been reported, but there is no increase in cases of ILI.

Influenza-like illness (ILI) is defined as patients presenting with fever of 100° F or greater, cough and/or sore throat in the absence of a known cause other than influenza.

No Activity: No laboratory-confirmed<sup>2</sup> cases of influenza and no reported increase in the number of cases of ILI.

**Sporadic:** Small numbers of laboratory-confirmed influenza cases or a single laboratory-confirmed influenza outbreak has been reported, but there is no increase in cases of ILI.

**Local:** Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed<sup>2</sup> influenza in a single region of the state.

**Regional:** This level does not apply to Delaware. Per CDC, regional does not apply to states with  $\leq 4$  regions<sup>3</sup>.

**Widespread:** Outbreaks of influenza or increases in ILI cases and recent laboratory-confirmed<sup>2</sup> influenza in at least half the regions of the state with recent laboratory evidence of influenza in the state.

Activity levels may not be comparable across states because some states may use different definitions for lab confirmation of influenza cases. Some states may include rapid diagnostic tests as confirmatory while Delaware considers viral culture or PCR as confirmatory.




Figure 1. Confirmed cases<sup>1</sup> of influenza by type and subtype, Delaware 2013-2014 Influenza Season.

The percent positive reflects only the percent testing positive for specimens submitted by WHO/NREVSS Collaborating Laboratories in Delaware (includes Christiana Care and the Delaware Public Health Laboratory). The percent positive does not reflect specimens tested by hospitals not participating in the WHO/NERVSS Collaborating Labs in Delaware.



# U.S. Outpatient Influenza-like Illness Surveillance Network (ILINet) (Sentinel) Provider Surveillance Network:

An ILINet (sentinel) provider conducts surveillance of influenza-like illness (ILI) in collaboration with the Division of Public Health and the Centers for Disease Control and Prevention (CDC). Data reported by ILINet providers, in combination with other influenza surveillance data, provide a national and statewide picture of influenza activity in the U.S.


Figure 2. Percentage of visits for influenza-like illness (ILI) reported by sentinel healthcare providers participating in the U.S. Outpatient ILI Surveillance Network (ILINet), Delaware 2013-2014.



**NOTE:** Data provided do not reflect the total number of individuals who have been infected with the influenza virus in Delaware during the reporting period as a result of the following factors:

- Many people ill with influenza-like symptoms do not seek medical care.
- Many who do seek medical care are not tested for influenza.
- The Delaware Public Health Laboratory (DPHL) is limited by capacity to processing a maximum of 3 specimens per day from each reporting entity.
