I. PURPOSE:

The purpose of this policy is to promote and maintain objective, consistent, impartial, and fair utilization management decisions. The policy shall describe the authorization review process for applicable substance use disorder (SUD) treatment for Delaware residents eighteen (18) years of age or older who are uninsured or underinsured. DSAMH-contracted programs that provide services for 23-hr Ambulatory Withdrawal Management (ASAM 2), Ambulatory Withdrawal Management (ASAM 2), Residential Treatment (ASAM 3.1 & 3.5), or Residential Detox (ASAM 3.7) must follow the steps outlined in this policy for authorization by DSAMH.

II. POLICY STATEMENT:

DSAMH shall conduct review of clinical and treatment authorization following the initiation of treatment. Initial review is based solely on the SUD review of authorization request form and other clinical documentation provided by the SUD Provider/Facility. Once the supporting clinical documentation is received by DSAMH SUD Utilization Review (UR), it is considered a formal authorization request.

III. **DEFINITIONS**:

"Authorization" means the agreement from DSAMH that a patient meets medical necessity as defined by ASAM criteria for substance use disorder treatment and that DSAMH will pay for treatment.

"Delaware resident" means an individual who is not eligible for an out-of-state Medicaid plan and meets either of the following criteria:

- 1. An individual is domiciled in a permanent location or maintains a place of abode that they stay in that is a building, structure, or vehicle within the limits of the State, and spends more than 183 days in the State.
- 2. A person who possesses a valid Delaware-issued identification card such as driver's license or non-driver identification card.

"Utilization Review" or "UR" means the review of clinical information to determine authorization approval or denial.

IV. <u>SCOPE</u>: This policy and procedure applies to all DSAMH-contracted providers that provide Ambulatory Withdrawal Management, 23-hr Ambulatory Withdrawal Management, Residential Detox, and/or Residential services for uninsured or underinsured patients.

V. **PROCEDURES/RESPONSIBILITIES**

- A. Exploration and Discovery of Insurance:
 - The treating SUD Provider/Facility is responsible to provide evidence that a patient is not
 covered under a private insurance, an out of state or DE Medicaid, or has a policy that does
 not cover SUD Ambulatory Withdrawal Management, 23-hr Ambulatory Withdrawal
 Management, Residential Detox, and/or Residential treatment facilities.
 - 2. This evidence is required prior to DSAMH's review of authorization request forms and clinical documentation for authorization of treatment.
- B. Submission of SUD authorization request form and other clinical documentation:
 - SUD authorization request form and other clinical documentation must be submitted to the DSAMH SUD UR email box DSAMH_EEU_ SUD@delaware.gov with the word "initial" in the subject line. SUD authorization request form and other clinical documentation faxed or submitted to another email box will not be accepted.
 - a. SUD authorization request form and other clinical documentation for initial review must be received within three (3) days post-admission to the SUD facility.
 - SUD authorization request form and clinical documentation received with errors or incomplete (after the 3rd business day post-admission) will not be reviewed.
 Notification of denial of authorization will be sent, and no exceptions will be made.
 - 2. Documentation to be submitted:
 - a. Clinical documentation shall include but is not limited to:
 - i. DSAMH SUD authorization request form,
 - ii. EOB, proof of insurance verification, or proof of lack of insurance at time of referral,
 - iii. Biopsychosocial assessment,
 - iv. ASAM criteria assessment,
 - v. Psychiatric evaluation and psychiatric notes, if available,
 - vi. Laboratory results to include urine toxicology screen,
 - vii. Collateral information,
 - viii. Discharge planning,
 - ix. Treatment plan,
 - x. Medication administration record,
 - xi. Clinical Alcohol and Opiate Withdrawal Assessment Scale, as appropriate,
 - xii. Progress/Group notes, and

xiii. Documentation of coordination of care with current providers.

- b. Other documentation:
 - i. Results of exploration and discovery of benefits,
 - ii. Application for Medicaid, and
 - iii. Government issued identification, if available.

C. Review of clinical documentation:

- 1. DSAMH SUD UR will conduct a review of clinical documentation to provide determination of authorization.
- 2. DSAMH SUD UR will respond with the authorization or denial of request within two (2) business days of submission.
- 3. DSAMH SUD UR may authorize up to 30 days, but each day of treatment must meet ASAM placement criteria and medical necessity based on documentation provided by the facility.
- 4. Failure to submit complete authorization request forms and treatment documentation could result in denial of authorization.
- 5. Frequency of reviews will be based on level of care, treatment progress of the client, and documentation provided by the SUD facility. The reviews shall be completed at least every 30 days.
- D. For any denials of authorization, reference DSAMH003 Provider Appeals Policy for next steps.
