## **History**

MOLST (Medical Order for Life Sustaining Treatment) implemented in 2012

Stakeholder feedback identified following issues:

- No standardized training for medical providers
- Paper-based form allows for errors, duplication and confusion for EMS

- Form, clinical and administrative processes not aligned with best practices
- Not transferable across care settings or state lines
- No interoperability with EHR, which creates an impediment to clinician adoption.



## **Project Impetus**

Bill H. 5374 signed in 2022:

- Transition from the current MOLST form process to the National POLST Paradigm
- Develop, implement, and operate a statewide electronic POLST IT system.
- Establish <u>POLST Trust Fund</u>




### Scope
