Session 1: Access

Action Items:

- Implement SB 122 surveys and standardize workforce data capture.
- Finalize solutions from preceptor roundtable and address barriers to clinical slots.
- Develop large-scale clinical training cohorts tied to hiring pipelines
- Explore shared simulation labs and joint training spaces.
- Build Aligned career ladders (HS – CAN – LPN – RN – BSN – Graduate).
- Expand scholarship and loan repayment programs.
- Scale rural outreach programs (ex. Mini - Med).



Session 2: Quality

Action Items:

- Evaluate options for VBC/AHEAD
- Promote Psychological Safety in Healthcare Settings



Session 3: Cost

Action Items:

- Develop a **comprehensive healthcare data strategy for Delaware**, with emphasis on value-based care implementation and policy decision support
- Consider funding appropriation for claims database sustainability beyond FY 28
- **Health Resources Board (HRB)**
 - Remove or increase equipment cost triggers, streamline approval process for minor modifications, maintain oversight for ownership transitions and major acquisition, and focus on preventing cherry-picking by for-profit entities.



Session 4: Provider Well-Being

Action Items:

- Engage human resource managers for employer healthcare purchasing education.
- Develop comprehensive provider credentialing reform recommendations.
- Develop legislative proposals for top-of-license practice across professions.
- Promote interoperable EHR systems across the state to reduce manual work and fragmentation.
