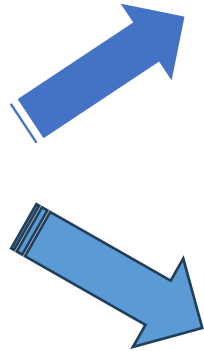

Implement Value-Based Care through Collaboration, Legislation and Regulations



Extend SB 120 Sunset & Modify Other Provisions

- Extend sunset date until program implementation
- Require an approach to include Medicaid and State Employee Plan
- Modify language to incorporate other provisions



Launch New Program Model

- Create sustainable multi-payer model
- Use tiered approach to include all interested providers
- Ensure meaningful payer-provider collaboration, reporting and education
- Standardize active panel management process

Consider AHEAD Model

- Work with multi-agency and stakeholder group to review and formulate application
- Prepare budget and timeline
- Submit application with Governor support (Jan. 2026)
- Develop implementation plan

Proposed Value-Based Care Strategies



- ❖ Pass legislation to extend SB 120 sunset, and modify key provisions as developed by DOI and stakeholders by March 2026
 - Adjustments related to high-cost claimants, medical expenses definition
- ❖ DOI/OVBHCD to develop and adopt regulations with stakeholder feedback, to design the new Delaware Program Model which has a tiered approach and reduces provider administrative burden by September 2026
- ❖ Recommend AHEAD Model
