Appendix A

Project Narrative

ChristianaCare Atlas LLC, US Health Partners (USHP) and Cardiology Physicians (USHP/CP) have executed a Letter of Intent to establish a new joint venture entity for the purpose of developing and operating a state-of-the-art cardiovascular surgery center with the ability to provide same-day cardiovascular procedures (“The Cardiovascular Surgery Center”). The Cardiovascular Surgery Center facility will include two (2) operating rooms and will be located on ChristianaCare’s Newark Campus Healthcare Center at Christiana (HCCC). The Cardiovascular Surgery Center will be jointly owned and operated by the Applicants, in accordance with the Operating Agreement that the parties are currently negotiating, which will be finalized prior to the submission of the Certificate of Public Review Application.

The Cardiovascular Surgery Center will:

- Reduce patient wait times for cardiovascular procedures by addressing limited operating room availability and expanding access to care through increased cardiovascular ASC capacity in New Castle County
- Enhance outpatient access to quality care by solely focusing on outpatient cardiovascular procedures that deliver the right care, in the right place to reduce health risks and increase patient comfort
- Decrease costs of care by transitioning appropriate cardiovascular procedures that are currently performed in an acute hospital setting to the appropriate outpatient setting
- Increase access and care coordination by operating with a primary focus of caring for those in the communities we serve in need of cardiovascular procedures and treatment

The estimated capital expenditure includes space renovation of an existing facility and equipment costs. Additional details about the entity’s operating structure and costs will be forthcoming in the Application.
