Dear Members of the Health Care Commission,

This letter serves as a formal Letter of Intent to apply for a Certificate of Public Review (CPR) to establish a new ambulatory surgery center (ASC) in western Sussex County, Delaware, anticipated to be located in the Bridgeville–Seaford corridor along U.S. Route 13.

The proposed facility would serve as the **primary center for vitreoretinal surgery on the Delmarva Peninsula**. At present, there is no facility in southern Delaware capable of providing retina surgery. As a result, patients residing south of Middletown—including all of Kent and Sussex Counties—must travel to Salisbury, Maryland to receive medically necessary vitreoretinal surgical care. This represents a significant and longstanding unmet need, particularly for elderly and rural populations who face transportation, financial, and health-related barriers to accessing care.

Establishing this ASC would substantially improve access to timely, high-quality surgical eye care for southern Delaware residents and is closely aligned with the State's recent initiatives to expand healthcare access in rural and underserved areas. By eliminating the need for out-of-state travel, the proposed center would reduce delays in care, improve surgical outcomes, and enhance continuity of care for Delaware patients.

Given the significant overlap in surgical equipment, staffing, and infrastructure required for ophthalmic subspecialties, the ASC would also provide **cataract, cornea, and glaucoma surgical services**. Access to these procedures is currently limited in Kent and Sussex Counties, resulting in extended wait times and constrained capacity. The proposed center would meaningfully expand surgical availability, decrease wait times, and improve overall quality and efficiency of ophthalmic care in southern Delaware.

In summary, this project addresses a clear gap in essential surgical services, supports the State's goals of improving rural healthcare access, and responds directly to the needs of a growing and aging population in Kent and Sussex Counties. We respectfully submit this Letter of Intent and look forward to working with the Health Care Commission throughout the CPR review process.
